## Official Rules

**2. How to Enter:** To enter the Promotion, you may do the following: visit [thecollectionrp.com/10313](http://thecollectionrp.com/10313) and complete the entry form. You will be asked to provide basic contact information.

**3. Eligibility:** The Promotion is open to legal U.S. residents 18 years or older. Void outside the U.S. and where prohibited.
