

**Win A Car  
OFFICIAL RULES**

NO PURCHASE NECESSARY TO ENTER OR WIN. PARTICIPANTS MUST HAVE INTERNET ACCESS PRIOR TO THE START DATE OF THE SWEEPSTAKES.

**ELIGIBILITY:** The Sweepstakes is open to legal residents of California who are eighteen (18) years or older at the time of entry. Void where prohibited by law.
