1. Official Rules. Entry to the "BenQ RevolutionEyes LCD Monitor Upgrade" (the "Upgrade") will constitute your full and unconditional acceptance of these Official RevolutionEyes Upgrade Rules and your agreement to be bound by them. You further accept that BenQ America Corp.'s decisions are final and binding in all matters related to this RevolutionEyes Upgrade. Winning a prize is contingent upon fulfilling all requirements set forth herein. These Official RevolutionEyes Upgrade Rules take effect immediately on your entry to the RevolutionEyes Upgrade. If these Official RevolutionEyes Upgrade. Rules are not accepted in full, then you should not enter the RevolutionEyes Upgrade.

of any brand in need of an upgrade. Employees of BenQ America Corp. and any of its parent and affiliate companies as well as the immediate family (spouse, parents, siblings and children) and household members of each such employee are not eligible. The Upgrade is subject to all applicable federal, state, and local laws and regulations. Void where prohibited.

4. Winner Selection and Prize. A BenQ RevolutionEyes LCD Monitor (MSRP approximately \$300) will be given away based on the winner's upgrade need as determined by BenQ at its sole discretion. Winner will be determined on the following two stages:

<u>Stage I</u>. Up to five (5) winner candidates ("Finalists") will be selected by a designated BenQ employee at his/her own sole discretion by October 6, 2014 based on the video describing the pressing reason for the upgrade submitted by the entrants.

<u>Stage II</u>. One (1) final winner will be chosen from the Finalists by a panel of designated BenQ employees by October 10, 2014 based on the most pressing reason for the upgrade supported by the video submitted by the entrant. BenQ's decision will be final.

5. Entries submission Period and Winner Announcement. The RevolutionEyes Upgrade begins on August 12, 2014 at 12:01 a.m. Pacific Standard Time ("PST"), ends on September 30, 2014, 11:59pm Pacific Standard Time (the "Upgrade Period"). The winner will be announced by October 17, 2014 via email to the winner and by posting on https://www.facebook.com/BenQUSA. Any entry that is not submitted by the indicated deadline (for any reason whatsoever, including technical difficulties attributable to BenQ's website), that is incomplete, illegible or that does not comply with the Official RevolutionEyes Upgrade Rules will be automatically disqualified.

6. How to Enter. During the Upgrade Period, visit http://info.benq.us/revolutioneyes with a valid email address for an accredited college or university, brand and model of current computer monitor owned by the entrant, and a link to a video with the reason an LCD monitor upgrade is needed. Video must be communicated in the English language and be no longer than 2 minutes in length. Video must not be obscene, lewd, violent or offensive and content must be suitable for the general public. By submitting your email address, you agree to the Official RevolutionEyes Upgrade Rules. Only one entry is allowed per person and one entry per account. Duplicate or multiple entries will automatically disqualify an entrant.

7. Account Holder. In the event of a dispute arising or related to the Upgrade, the authorized account holder, at time of entry, of the email address used to submit the respective entry will be deemed to be the entrant and must comply with these Official Upgrade Rules. The "authorized account holder" is the natural person to whom an email address is assigned by an educational institution that is responsible for assigning email addresses for the domain associated with the submitted email address. Each entrant may be required to show proof of being the authorized account holder.

8. Winner Notification and Claiming the Prize.

a. Potential final winner will be notified by email by October 10, 2014 and will have five (5) days from the date of the notification to respond with his or her full contact information and claim the prize or forfeit.

b. The email notice will be accompanied by the following documents: (i) Affidavit of Eligibility and (ii) Liability & Publicity Release ("Forms").



c. The Winner will be required to execute and return the Forms to BenQ, within ten (10) days of the notice date in order to claim the Prize.

10. General

a. You understand that you will not receive any compensation or credit for use of your entry, other than what is described in these Official RevolutionEyes Upgrade Rules.



b. BenQ will only accept one entry per person and per email address. The same person cannot enter the RevolutionEyes Upgrade via two different email addresses.

d. No cash alternative to the prize will be offered.
