DATES OF THE PROMOTION AND DEADLINE FOR ENTRY - From Tuesday, July 1st at 12pm (GMT+1) to Tuesday, July 8th at 5pm (GMT+1) 2014. Deadline for entry is Tuesday, July 8th at 4pm (GMT+1).
