- 1. An order that the Registrar issue certificates of pending litigation against the lands and premises legally described in Schedule "A" (the "**Property**"); and

#### THE GROUNDS FOR THE MOTION ARE:

- 1. The Applicant has commenced an Application against the Respondent in which an interest in land is in question;
- 2. The Applicant is the court-appointed receiver and trustee in bankruptcy of a number of related companies that operate, among other things, a large marina in Keswick, Ontario;
- 3. The Applicant's review of the books and records of the insolvent companies suggest that the purchase and carrying costs of a number of properties have been paid for by one of the companies under receivership, Crate Marine Sales Limited ("CMS");
- 4. Some of the properties at issue are adjacent to the main marina lands used by the Companies in Keswick, and the Applicant has already obtained a certificate of pending litigation against these properties;
- 5. In its further review of the records of the insolvent companies, the Applicant has identified the Property as another property which CMS appears to have paid all of the funds required to purchase and maintain it;
- 6. The Applicant has commenced an application which claims, among other things, a certificate of pending litigation against the Property;
- 7. The Property has been listed for sale;

8. A certificate of pending litigation is required so that the Property is preserved until its

proper ownership is adjudicated;
