### **ORDER**

THIS MOTION, made by Patricia Covich, as Mother and Natural Guardian of Daniel Covich, an Infant under the age of fourteen (14) years old, and Patricia Covich, individually, for an Order for leave to commence and continue an action against Natura World Inc. ("Natura World" or the "Bankrupt") in the law suit commenced in the Supreme Court of the State of New

York, New York County, Court File No. 100608/2010 between Patricia Covich, as Mother and Natural Guardian of Daniel Covich, an Infant under the age of Fourteen (14) years old and Patricia Covich, individually, as Plaintiffs and Natura World Inc., as Defendant, (the "Covich Action") for the purpose of obtaining judgment establishing liability of Natura World and recovering any proceeds of insurance available to satisfy the claim of the moving parties was heard this day at the London Courthouse, 80 Dundas Street, London, Ontario,

ON READING the Affidavit of Tracey L. Baker, filed, and on hearing the submissions of agent of the American counsel for the Moving Parties, and on reading the Consent of the Trustee in Bankruptcy, A. Farber & Partners Inc. (the "Trustee"), filed,

- 1. **THIS COURT ORDERS** that the time for filing and service of the Notice of Motion and the Motion Record be and it is hereby abridged, and that the service, including the manner of service of the motion materials, be and is hereby approved and validated, that the motion is properly returnable today, and that all parties entitled to notice of this motion have been properly served and further service thereof is hereby dispensed with.
- 2. **THIS COURT ORDERS** and declares that section 69.3 of the *Bankruptcy and Insolvency Act* is not effective against the Moving Parties, and leave is hereby granted *nunc pro tunc* to commence and continue the action commenced in the Supreme Court of the State of New York, New York County, Court File No. 100608/2010 for the purpose of obtaining judgment to establish the liability of Natura World Inc. and to recover any proceeds of insurance available to satisfy the claim of the Moving Parties;
- 3. **THIS COURT ORDERS** that in the event the trustee in bankruptcy of Natura World Inc. does not see fit to defend the action, it shall not be liable to:

- (a) be examined for discovery;
- (b) file an affidavit of documents; or
- (c) costs of the Action.
