

## California Giant Berry Farms® "Cloudy with a Chance of Meatballs 2 Mystery Prize Pack Giveaway" Official Rules

One (1) drawing period will be conducted per the schedule below, in which thirty-four (34) winners will be randomly selected from all eligible entries received during the Overall Promotion Period.

By participating in the Promotion, each entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of the Sponsor, which shall be final and binding in all respects. By participating in the Promotion, participants agree to release, discharge and hold harmless Promotion Entities (defined below) from any and all damages whether direct or indirect, which may be due to or arise out of participation in the Promotion or any portion thereof, or the acceptance, use/misuse or possession of prizes. Return of First Notification as undeliverable, or failure to comply with any of these requirements will result in disqualification, forfeiture of the prize and the selection of an alternate winner.
