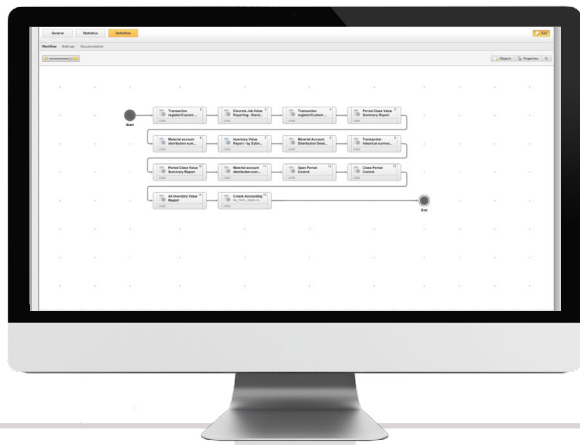

This creates a seamless workflow, providing businesses with an overview of the entire process. For example, automation of the general ledger import/post process allows you to set up external data feeds that work without any manual intervention.

Fully Integrated File Transfers

With native data transfer capabilities incorporated as part of Automic Workload Automation for Oracle E-Business Suite, file transfers are fully coordinated when moving data between remote locations, external business partners, or simply between internal systems, providing consistent and reliable straight-through processing and making business processes more predictable with fewer errors.

Scan Outputs for Business Success

Automic Workload Automation for Oracle E-Business Suite is able to scan outputs such as data files and system output logs, making it possible to catch process errors in Oracle E-Business Suite or any other application as they occur in the business process. This enhanced error checking is extended across external applications, ensuring that all external data is incorporated.

Track Child Processes

When you run a process in Oracle E-Business Suite, all child processes are tracked by Automic Workload Automation for Oracle E-Business Suite. Parent processes are tracked until all of their child processes have completed. If a child process fails, the parent process shows a failed status, making it much easier to spot problems and correct them in a timely fashion.

Risk Reduction and Compliance Assurance

Automic Workload Automation for Oracle E-Business Suite reduces risk by applying tight audit reporting and control procedures across all applications – providing a complete audit trail that documents any changes to the process or abnormalities that occur. Audits and controls ensure that accounting procedures satisfy governance and compliance regulations, such as SOX and Basel II.
