## Details on Financial Benefit

For a limited time, the chapter of brightpeak financial is offering a need-based grant, referred to as a "financial benefit," of up to \$1,000 to eligible mothers. The chapter of brightpeak financial wishes to provide this benefit because it believes that the death of a mother is a tragic event, and a family should take time to grieve rather than worry about an immediate financial burden.

### To become eligible for the financial benefit, a mother must:

1. Be a paying member in MOPS International and reside in the United States on the date of membership application; and
2. Be a member of the brightpeak financial chapter or a member of another chapter of Thrivent Financial at the time of death; and
3. Die within 12 (twelve) months from the date of application.

To be eligible to seek payment on the financial benefit, an individual, referred to as an "applicant," must be the designated guardian of the eligible mother's children. The applicant will be required to provide personal information to verify the applicant's relationship to the eligible mother. The applicant will also be required to provide information to help brightpeak financial verify the death of the eligible mother such as an obituary or death certificate.

Application to receive the financial benefit must be submitted within 180 days of the eligibility period expiration date.

Receipt of the financial benefit and the amounts awarded are in no way guaranteed and will be awarded at the discretion of the chapter of brightpeak financial based upon a determination of need through an interview and grant application process.
