The following outlines CORWIL Technology's privacy policy and details the measures we have taken to safeguard and protect your privacy. # What Information Is Collected?

Categories of information collected include your name, e-mail address, postal address, phone number and credit card number. In addition, we may maintain a record of your purchases from CORWIL.com. We may also acquire names and mailing addresses for select mailings from third parties. On occasion, we may combine information you provide with other demographic information available to us.

# How Is My Information Used?

When you Request a Quote from CORWIL.com, we use your information to process your request and to answer any questions you may have submitted through our website about the nature or status of your business Quote and request. We may use the information to provide you with periodic e-mails and mailings about CORWIL's business activities, specifically our Blog, related industry insights and new services we wish to inform you about.

# Will My Information Be Shared?

To respect your privacy, CORWIL Technology will not sell or rent the personal information you provide to us online to any third party. CORWIL only shares information about our clients with reputable third parties to provide better service to you. These services may include maintaining and managing customer information and providing customer service requests. We do not authorize those third parties to make any other use of your information or to send you unsolicited e-mail. In addition, CORWIL may share information that our clients provide with specially chosen marketing partners. We also may share aggregated statistical or demographic information about you with third party companies in a manner that does not reveal your personal identity.

When we respond to business requests and conduct customer surveys, CORWIL customers who choose to participate may be asked to provide personal information.
