2013 Legislative Actions and Accomplishments



- Sleep apnea legislation enacted
- SKILLS Act (job training program reform) passed by the House
- HOS
 - Letters from key members for 90-day stay
 - Appropriations amendment
- ATA witnesses at 5 Hearings



Hours of Service Legislation



- H.R. 3413
 - Would reinstate old restart rule
 - Require GAO to analyze FMCSA's restart study & evaluate FMCSA's Cost-Benefit analysis
- 45 cosponsors to date
- Small Business Committee hearing 11-21, highlighting ATRI research



2014 Legislative Priorities



- Highway reauthorization
 - Fuel tax increase with indexing
 - Dedicated highway freight program
 - Increases in truck productivity
- Congressional oversight/action on HOS and CSA
- Energy legislation, including incentives
- Comprehensive tax reform
- Change mission of FMCSA



Grassroots



- Call on Washington
 - 28 States
 - 357 Hill visits
 - 436 Trucking Executives
- 12 terminal visits



2014 Elections



Senate (55 D, 45 R)

35 Seats up; 21D, 14R

7 Senators have announced they will retire (Rockefeller, Levin, Johnson, Baucus, Johanns, Chambliss, Harkin)

Charlie Cook ranks

4 D seats as toss up or lean

1R as toss up



2014 Elections



- House (232 R; 200 D; 3 vacancies)
 - 5D open seats; 12R open seats
 - Another 8D and 8R possible open seats

- 28D's and 19R's won with less than 55% of the vote in 2012

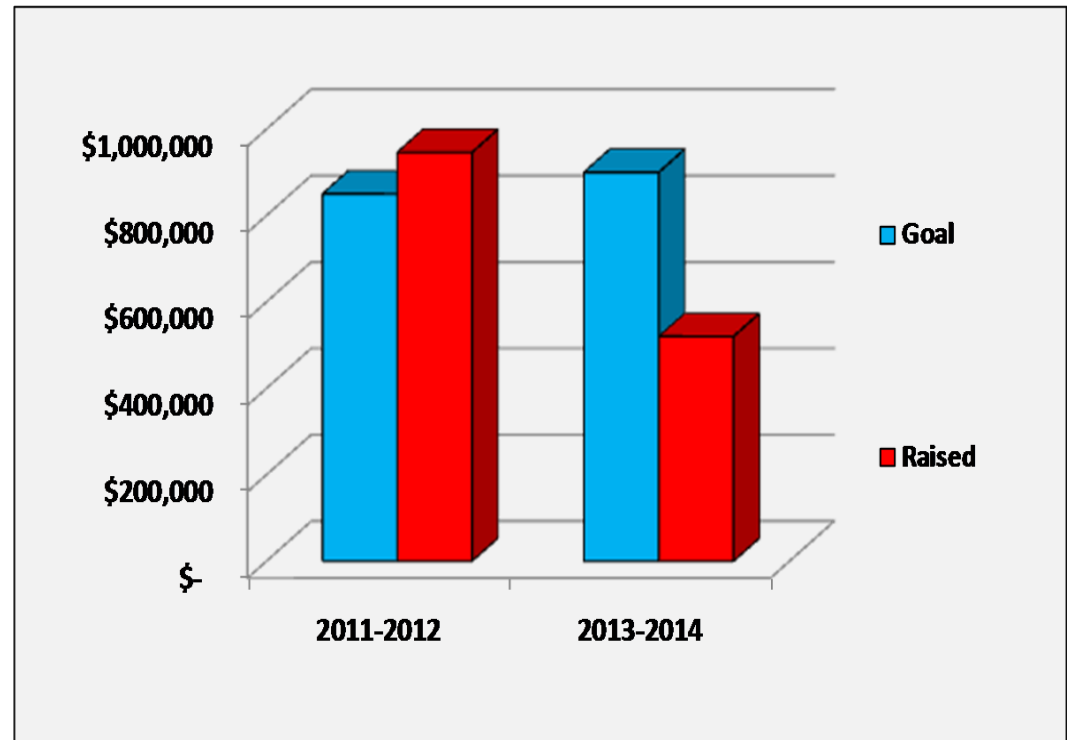

DOL	Persuader Rule	Winter
DOT – NHTSA	Mandatory Speed Limiters	Summer
DOT - FMCSA	CSA Safety Ratings	Summer
DOT - FMCSA	Unified Registration System #2	Fall
