Renovation and reopening announcement of RIHGA Royal Hotel Kyoto

The Royal Hotel, LTD. ("Royal Hotel") today announced the renovation and reopening of RIHGA Royal Hotel Kyoto ("the Hotel"), which is located in Shimogyo-ku, Kyoto and first opened in 1969. The Hotel will be closed for seven months from February 2016 due to large-scale renovations and is scheduled to reopen in autumn 2016. The renovation will enable the Hotel to provide all of the facilities and services of a first-rate contemporary hotel, while retaining the historic feel and traditional elements of Japan's most culturally rich city.

On February 13, 2015, Royal Hotel signed a tripartite agreement regarding the transfer and business consignment of the Hotel with Florentia TMK ("Florentia") and RRH Kyoto Operations GK ("RRH Kyoto Operations"). Pursuant to the hotel management contract with RRH Kyoto Operations, Royal Hotel will continue to operate the Hotel under its current name.

Throughout its long history, the Hotel has developed a loyal and distinguished clientele, and it continues to attract more customers including more and more overseas visitors. In this way, the Hotel continues to contribute to the development of Kyoto's tourism industry. By enhancing the current facilities, the renovation will enable the Hotel to provide a further enhanced level of comfort and convenience.

Change of ownership

Royal Hotel currently operates the Hotel and owns the land and building of The Hotel. The assets of the Hotel are scheduled to be transferred to Florentia and leased to RRH Kyoto Operations on March 27, 2015. On the same day, Royal Hotel is planning to sign a hotel management contract with RRH Kyoto Operations, pursuant to which Royal Hotel will continue to operate the Hotel as the RIHGA Royal Hotel Kyoto.
