2. HAZARD IDENTIFICATION

Emergency Overview

Grower's Secret Pro is considered to be nontoxic according to EPA Standard Acute Oral Toxicity test.

Dark liquid, reddish brown color

Health Effects: Eyes

This product may cause allergic irritation to eyes if allergic to mushrooms, pineapple, papaya or molasses.

Health Effects: Skin

This product may cause irritation to skin with prolonged or repeated contact.

Health Effects: Inhalation

Inhalation of vapor or mists of the product may be irritating to the respiratory system in people allergic to mushrooms, pineapple, papaya or molasses.

3. FIRST AID MEASURES

EYES

Immediately flush eyes with water for at least 15 minutes while holding eyelid open. Seek medical attention if irritation persists.

SKIN

For skin contact, flush with copious amounts of water. If irritation persists, get medical attention. Immediately take off contaminated clothing. Wash contaminated clothing before reuse.



INHALATION

If symptoms are experienced, remove source of contamination or move victim to fresh air. If breathing is difficult, give oxygen. Seek medical assistance.

INGESTION

If the material is swallowed, get immediate medical attention or advice.

Use general ventilation. Local exhaust is suggested for use, where possible, in enclosed or confined spaces.

Personal Protection Equipment: Skin

Personal Protection Equipment: Respiratory

In enclosed areas, such as a greenhouse, use a respirator to avoid inhaling heavy mist. In well ventilated areas, use a particle mask.

Eye wash fountain and emergency showers are recommended.
