

TYPES OF AVAILABLE AID FOR SUMMER

Federal Student Aid Loan Program Funds. **Direct Subsidized Loan:**



• For undergraduates • Interest is paid by the U.S. Department of Education while

- the student is in school and during periods of deferment **Direct Unsubsidized Loan:**

• For undergraduates and graduate students • Borrower is responsible for all interest

- For graduates/professional students and for parents of dependent students

• Credit-based loan

Direct PLUS Loan:

• Borrower is responsible for all interest



Some Pell Grant Recipients may be eligible for Pell Grant funds during the summer, if you attended less

Grants and Scholarships are **NOT** typically available for Summer Session.

Additionally, some Pell Grant recipients may be eligible for Pell Grant funds during the summer even if The UNCG Financial Aid Office will process your Summer Financial Aid Application to determine your eligibility for summer aid.

DETERMINING YOUR SUMMER ELIGIBILITY

Your eligibility for federal student loans during the summer is based on a number of factors, including:


Your grade level

How much you've already borrowed during the current academic year (here at UNCG and/or elsewhere)

Number of credit hours you will be taking



- Not all students will be eligible for financial aid for Summer Session.
- Borrowed your yearly limit or your overall aggregate (total) limit on federal
- student loans Have received your full yearly allotment of Pell Grants funds



DISBURSEMENT OF FINANCIAL AID FUNDS

Your summer award will reflect your full eligibility for all types of available aid. UNCG cannot guarantee that your awarded financial aid will cover all of your summer expenses
