

## Out To Lunch – The Collection at RiverPark Program Official Rules

Instructions on how to claim a gift form part of these Terms and Conditions. Participation in this offer is deemed acceptance of these Terms and Conditions.

The Free Gift with Purchase offer is open only to legal residents of the fifty (50) United States and District of Columbia who (a) are at least eighteen (18) years of age or the age of majority in their jurisdiction of residence at the time of entry, whichever is greater.
