

Secondary Review to Locate Errors and Reduce Fraud

As a complementary service to Chrome River EXPENSE, our Business Rules Engine monitors expense spend to ensure compliance with your organization's defined business and travel policies and to ensure your approvers review the expenses before accepting them. However, your organization may still want to initiate a secondary audit review for certain expense charges, receipt verification and other defined business requirements.

Intelligent auditing

No need for auditors to spend hours manually scouring through stacks of expense reports. Chrome River AUDIT simplifies the process by highlighting the expense reports that need the most attention. A powerful rules set analyzes the expense charges, attributes of the charges, attributes of the expense submitter and even an audit risk level of the submitter to automatically trigger reports to the audit queue for additional review. By narrowing down and highlighting the expense reports that need the most attention, auditors spend less time scrutinizing stacks of reports and have more time to focus on other aspects of their jobs.

Flag expense items

We don't make auditors search for items that need to be reviewed. Audit triggers and intelligent samplings arrive in the audit queue and are flagged with a defined audit concern so the auditor knows exactly what to look for. Our simple tools allow auditors to return items in question to the employee with a predefined response as to why the transaction is in question, along with additional notes. This process removes the manager from the role of policing an employee's expense submissions and lets the system send an automated message that the employee can respond to. The system maintains the threaded discussions with the employee about the transactions in question for future reference.
