- **Authorizations and eligibility** for hundreds of commercial payers and Medicaid can be **batch-processed** through the scheduler. Appointments requiring attention are clearly “red flagged” displaying corrective actions needed by the practice or patient prior to the appointment
- **Co-payments and balances due** by single or multiple guarantors are viewable through the scheduler

- **Eligibility verification** typically takes a few seconds to perform and it ensures patients actually have the coverage presented. Any payer issues / pre-certifications required are displayed which can be relayed to guarantors for reconciliation prior to the appointment.
- Tracks **numbers of allowable visits** to help ensure authorizations are obtained when needed
