#### INTRODUCTION

As frustrating as fire codes can be for property managers, property owners, facilities managers, and anyone involved in the maintenance and operations of a building, they are there to protect lives and property. **The National Fire Protection Association** (NFPA) develops these standards that are adopted and used to prevent fire emergencies and life threatening situations around the world.

**NFPA 1**, for example, provides a guideline of requirements for building reviews and inspections. It has been adopted by 19 different states.

### HOW TO USE

How can you know which fire codes you are legally required to abide by, and which ones are merely suggestions? This question can be difficult to answer because the fire code changes depending on what state your building is located in.
