The MetroHealth System and VNA of Ohio Announce Preferred Provider Agreement

**June 21, 2016 – Cleveland, Ohio** – The MetroHealth System and Visiting Nurse Association of Ohio (VNA) are partnering to provide patients with an easier transition when going home from the hospital. VNA of Ohio will be a preferred provider for MetroHealth for home care, giving patients access to a nursing team at home with the same level of expertise as the nurses who cared for them in the hospital.

When patients are getting ready to leave the hospital, they have a choice for which home health care company will continue their care. Having the VNA easily accessible makes the choice less stressful for patients, and allows MetroHealth clinicians to be confident patients are receiving expert care and continuing to recover at home.

By working together, MetroHealth and the VNA are able to focus on the patient experience, quality of care and patient outcomes, while managing costs.

"Seamless coordination from acute to post-acute care is essential for patients recovering from injury, illness, or surgery, managing a chronic condition, and/or receiving end-of-life care. Our partnership with MetroHealth will allow these patients, and their families, to receive higherquality services through a coordinated health system," states Claire Zangerle, VNA of Ohio President and Chief Executive Officer.

"The mission and values of the VNA align with ours at MetroHealth and we are confident its nursing team will keep patients healthy once they leave the hospital," said Daniel Lewis, chief operating officer at MetroHealth. "This partnership eases the burden for families, ensuring that they will continue to receive the care they need in the comfort of their home."
