Credit Agreement

We, _____, hereby agree to the terms of sale listed on each Secure Components LLC invoice. By signing this Agreement, we represent and warrant that we are financially able to meet any commitments we may make with Secure Components LLC. In the case of a sale on open account, we agree that Secure Components LLC may charge us a financing fee of *two and one-half percent (2.5%)* per each thirty-day period, or part thereof, for any invoice that is past due. We understand that if any part of our account becomes past due, and then the entire account, regardless of any terms to the contrary, shall become due and payable immediately. If the bank returns any check of ours unpaid for any reason, we understand, and agree to pay Secure Components LLC \$50.00 for each unpaid check. Additionally, we agree that, should we choose to use a credit card to pay any part of the balance due on our account later than one day after the date of invoice, Secure Components LLC may charge us a service processing fee of 5 % of that payment amount. We understand and agree that, if any amount we owe to Secure Components LLC is collected through an attorney, collection agency, or any form of litigation, then all collection expenses, including, but not limited to, attorney's fees, court costs, collection service fees, and any other related costs, will be added to the amount that we owe to Secure Components LLC. In order to induce Secure Components LLC to extend credit for the purchases of Secure Components LLC products and for other good and valuable consideration, we hereby convey, grant and transfer to Secure Components LLC a purchase money security interest in the products and/or



services we buy from Secure Components LLC and all proceeds related to those purchases until we perform all our obligations due to Secure Components LLC. Furthermore, we understand that Secure Components LLC does not accept sequential liability in any transaction with us. If we are a proprietorship, partnership, or personal guarantor we authorize Secure Components LLC to order a consumer credit report in connection with the review of existing and future extension of credit. We agree that our transactions with Secure Components LLC, Inc shall be governed by and construed in accordance with the Laws of the State of Pennsylvania. We further agree that any lawsuit or arbitration between Secure Components LLC, and ourselves shall be brought only in the state or federal courts of Pennsylvania. We understand that Secure Components LLC sole option, any controversy or claim arising out of, or relating to, this agreement, or the breach thereof, maybe settled by binding arbitration in accordance with the Pennsylvania Arbitration Law and administrated by the American Arbitration Association under its commercial arbitration rules.
