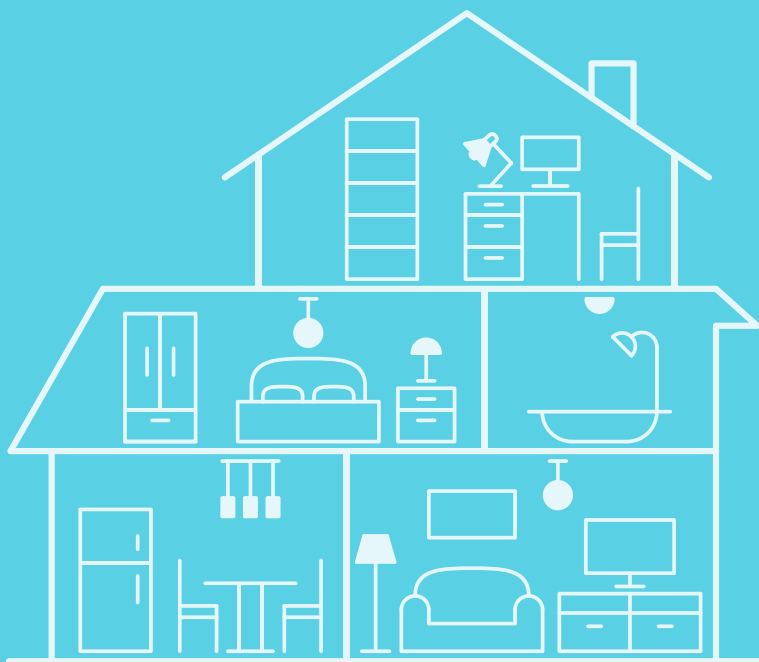

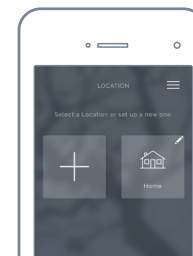

CLICK ANYWHERE

To toggle light on and off



MENU

Visible when Switch is on



TIMER MODE INDICATOR

Visible when a Timer is active



DIMMER BAR

Tap or slide to adjust brightness

An area of lights in your home—often a room or floor



SCENE

One or more lights customized to a preset dim level



TIMER

Automatically turns off after a period of time



SCHEDULE

Automatically turns lights on and off during the week



WIDGET

Control your lights from your home screen



WIFI BRIDGE

Connects Deako Bluetooth Switches to your WiFi Network

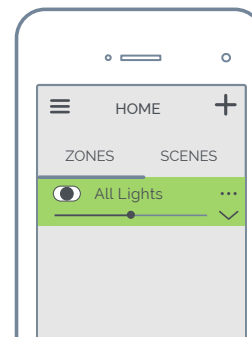
