Emergency Overview: Danger!

Section 4, First-Aid Measures

Show this safety data sheet to the doctor in attendance. Get medical attention immediately.

- **Eye Contact:** Check for and remove any contact lenses. In case of contact, immediately flush eyes with plenty of water for at least 15 minutes
