

# Quick Facts About Westminster Village

As Kent County's only Continuing Care Retirement Community (CCRC), Westminster Village offers:

- A 60-bed, skilled nursing and rehabilitation facility
- 42 Assisted Living apartments with kitchenettes and private bathrooms
- 17 suites in the secured Alzheimer's and Memory Support Services neighborhood
- 69 spacious Independent Living apartments
- 50 comfortable Independent Living cottages

The skilled nursing facility accepts Medicaid and Medicare, and is licensed by the Delaware Department of Health and Social Services.

Westminster Village is accredited through the Commission on Accreditation for Rehabilitation Facilities (CARF-CCAC).



## The Challenge



In Dover and its surrounding communities, the accessibility of transitional care for patients leaving the hospital with complex medical issues is not readily available. In fact, area residents most often utilize such services in Christiana or Milford to assist them in this transition. These locales pose a challenge for seniors and their families with regard to transportation and time required to visit and support their loved one. Distance can be a daunting barrier for those challenged by transportation or time.

Westminster Village is ready to address this challenge and meet this need through the establishment of a Transitional Care and Recovery Care Services program in our newly renovated skilled nursing and rehabilitation facility. This new service will not only provide state-of-the-art physical therapy, occupational and speech therapies, but also respiratory therapy and other services, all to ensure that we are providing the very best care.

## The Solution

A \$10 million investment is being made to the overall renovation of the Westminster Village Health Center. To assist with this substantial renovation, The Campaign for the Very Best Care has been organized with a goal of \$1.55 million directed to the development of a state-of-the-art Transitional Care Unit (TCU). Included in the TCU will be:

- 14 private resident rooms with private baths
- Amenities to enhance the therapeutic experience
- New equipment to aid in the progress of recovery and transition back to home
- Separate area for physical, speech and occupational therapy services

Financial support is being sought from foundations, corporations and individuals. Westminster Village is a 501(c)(3), tax exempt organization. A variety of giving options are available with pledges accepted and paid over a three year period.
