President's Letter



This is the third issue of *Mission in Motion*, which summarizes the community benefits provided by Presbyterian Senior Living at its various locations in Pennsylvania, Maryland,

Delaware, and Ohio. Presbyterian Senior Living was founded in 1927 as a charitable expression of the Presbyterian Church to meet the needs of seniors who lacked the resources to pay for the care they needed. While we have added a full range of services to seniors of all income levels, we are still focused on "relieving the distress and hardship of the aging." While providing charitable care is at the heart of what we do every day, the *Mission in Motion* report includes a variety of other activities that we describe as a "community benefit."

- **Education and Training** – On-site educational offerings extended to the wider community, often in conjunction with other community groups.
- **Community Outreach** – Programs both on-site and in conjunction with local schools, churches, senior centers, and in other community venues.
- **Resident and Staff Volunteer Efforts** – The entire PSL family is engaged in volunteer service to help their neighbors and to improve their communities.
- **Civic Engagement** – Participate in civic activities that foster awareness of issues that affect the community and provide direct assistance in solving problems as they are identified.
- **Paying Taxes** – Even though PSL is legally exempt from many forms of taxation as a charitable, tax exempt organization, PSL

pays over \$3,474,639 in taxes to support the health of the communities in which we reside.

- **Employment** – We employ nearly 3,000 individuals, supporting families, which adds millions of dollars to the economic vitality of the community.

While this report is an attempt to provide a clear picture of PSL's community benefit profile, it is not a complete description. In my travels among the Presbyterian Senior Living family, I frequently discover new expressions of service that could be added to this report. In that respect, the *Mission in Motion* report is a snapshot of a constantly evolving ministry.

Community Benefit Program – Understanding How it Works



Overview

The Community Benefit Program of Presbyterian Senior Living consists of outreach services, programs and initiatives that help to fulfill our mission and charitable purpose. These activities help make us a good neighbor in the communities we serve by providing quality care to our residents; extending our reach to those individuals not living on our campuses; and offering a caring place to work, donate and volunteer.

Whether it is a group of residents joining together to serve their community or employees giving their time as scout leaders, Sunday school teachers, or other volunteer service, good works are being performed every day within the PSL family. Some actions are small and silent, while others make a bold statement that we take pride in what we do.

Serving those in the greater community is PSL's way of giving back and showing that we are worthy of the public's confidence in us as a not-for-profit, faith-based organization.

This report highlights the period from July 1, 2012 through June 30, 2013. Included are examples of activities in each location and a financial estimate of the impact on the local communities we serve.

Social Capital

Why should Presbyterian Senior Living be involved in a community benefit program? First of all, it is the right thing to do in the communities in which we reside. Secondly, a healthy community is a better place to serve seniors and a more positive work environment for our staff to achieve our mission. Also, as a not-for-profit organization, we believe that

we have an obligation to provide for the good of the community in order to justify our tax exempt status.

By supporting the people; clubs; schools; churches; businesses, government entities; social service agencies and others, we strengthen the fabric of the larger community.

Outcomes and Measurements

There are many ways to measure the impact of a community benefit program. However, no one set of measurements can completely show how much these efforts benefit a community. In this report, we are highlighting activities performed by our residents and employees and offer an attempt to measure their impact in financial terms. While not precise, these activities have inspired others to get involved in their communities as a direct result of PSL's influence.

Benevolent Support

Skilled Nursing

Approximately 55% of the residents in our skilled nursing facilities are Medicaid-eligible. Presbyterian Senior Living Communities accept Medicaid reimbursement as payment in full. We consider benevolent support to include the



difference between our normal charges and the payment we receive from Medicaid.

Independent Living

Presbyterian Senior Living provides benevolent support to independent living residents unable to pay the established monthly fee and other reasonable living expenses in the form of reduced fees.

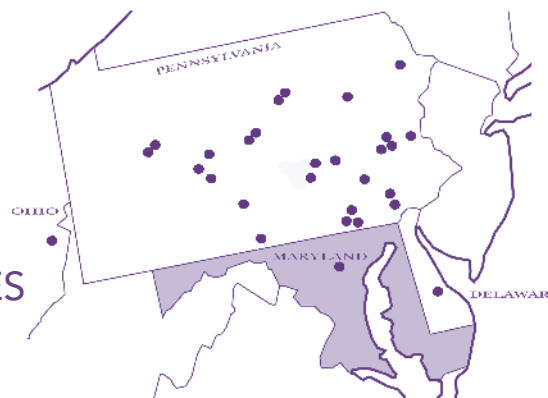
Personal Care/Assisted Living

The Easton Home has had another successful year participating in community outreach and civic engagement programs. The events and opportunities include: breakfast for local clergy; Red Hat luncheon for neighbors and residents; ice cream socials for Arndt Church

Wonderful desserts and beverages are served by female staff dressed in long flowing period gowns and the men wear black tailored period suits. In the main parlor, live music is played by local harpists, string quartets, pianists and jazz quartets.



Glen Meadows Retirement Community



The community surrounding the Glen Meadows Retirement Community in Glen Arm, Maryland, provides wonderful opportunities for residents and staff to volunteer and engage in community life. Our resident Chapel Committee is responsible for generous donations throughout the year to the Glen Meadows Foundation, Baltimore Rescue Mission, Our Daily Bread, Manna House, Catholic Relief Services, and Salvation Army. The Catholic Services Committee provides donations to St. Vincent's DePaul of Baltimore. The Care Wear Committee donates handmade blankets, gowns, and hats to local shelters and hospitals. Talented residents and staff made fleece blankets for cancer patients receiving treatment at Mercy Hospital. The Boys and Girls Club of Baltimore benefited by a book drive held at our community with the donation of 85 books.

Residents and staff donated used purses to sell with proceeds sent to the House of Ruth in Baltimore. Residents, staff and guests walked during Breast Cancer Awareness month. All of the proceeds were donated to the American Cancer Society.

Our Communities

Green Ridge Village



Green Ridge Village is a picturesque community in Newville, Pennsylvania, adjacent to two local favorite attractions, the Big Spring Creek

and the Cumberland Valley Rail Trail. The Big Spring Creek flows at the original entrance to the community and is a widely-known, spring-fed trout stream. The Cumberland Valley Rail Trail is approximately ten miles in distance and is designed for use by cyclists of every age and



fitness level. The community is a haven for nature enthusiasts, with 350 acres covered by trails and benches. It is not uncommon for community members to see wild turkeys and fawns.

Independent living residents have also focused on maintaining the population of the Northeastern Blue Bird. They have built and maintained over fifty houses. They have had twenty-two fledged blue birds their first year, forty-four their second year, and for this third year of the project they have had fifty-six fledged from these blue bird houses.

Residents of GRV help volunteer at vital ministries throughout the community such as the woodworking group, model railroad group, grief support group, thrift shop, gift shop, and in the skilled nursing building. Staff is also committed to keeping our surrounding community cleaner by supporting local highway cleanups once a

The move to their new home and the original intent of Judge Henry G. Long has inspired residents to concentrate on giving back to their community. A dedicated team of residents provide volunteer support to local churches, Lancaster General Hospital, and senior centers. A group of residents hosted a flea market with all monies collected donated to a needy family in Lancaster. Additional activities are planned to collaborate with other community groups to support local churches and neighborhood programs.

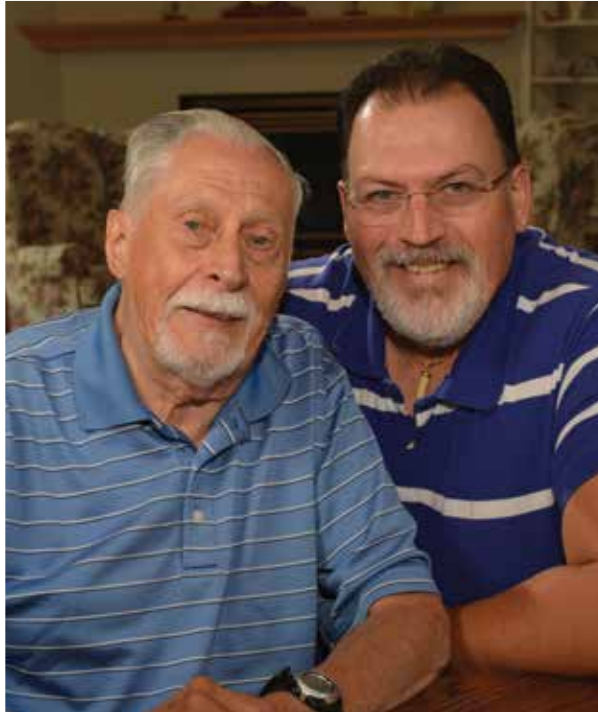

St. Andrew's Village

St. Andrew's Village (SAV) in Indiana, Pennsylvania, continues to expand its engagement in the greater community by reaching out and partnering with an increasing number of local groups and organizations. We have expanded our offering of SAV's



common space to community groups which now includes the Chamber of Commerce, International Rotary, Better Business Group, Indiana University of Pennsylvania (IUP), Area Agency on Aging (AAA) and the Jimmy Stewart Museum. SAV's annual car show and lawn concert has become one of the larger events in the community, drawing hundreds each year. Over the past three years, great food, the energetic Polka band and Indy Andy have helped to make the SAV Groundhog Day breakfast a "must-attend" event for community members.

SAV's relationship with IUP continues to grow with clinical experiences provided to nursing, dietetic and exercise physiology students, plus adding therapy clinical experiences. SAV partners with the local Red Cross to host a biannual blood drive. SAV hosts the Visiting Nurse

Association's fall flu clinic, a grief in-service, and joined with the Rotary Club to do roadside clean up as part of its Adopt-A-Highway initiative. Collaborating with the local Area Agency on Aging, SAV sponsors and hosts the seniors' safe driver's course each fall and spring and holds a regular senior crime prevention seminar for the surrounding community. As a part of our civic engagement, SAV hosts town hall meetings for state congressmen, and is actively involved in advocacy in federal and state issues. Campus administrators and staff also visit political leaders in Harrisburg and on Capitol Hill.

Many SAV employees voluntarily give of their time, talent and resources to serve the greater Indiana community by leading parent/teacher associations; coaching youth teams including travel soccer and high school basketball; serving on school boards and volunteering

There are two very special annual events held at Sycamore to connect with neighbors and the wider community. The Safe Halloween Night provides fun for community children who enjoy special candy, apple cider and games. Montoursville residents also look forward to the Annual Community Mardi Gras Night enjoying good food and beverage, music and fun.

Ware Presbyterian Village

Ware Presbyterian Village is located in the historic community of Oxford, Pennsylvania, in the beautiful rolling hills of the Brandywine Valley. Oxford was located near the half-way point on the main road from Philadelphia to Baltimore.

Ware provides meeting rooms and ancillary support for local organizations, clubs, boards, and student music recitals. Local college nursing students receive clinical training at the Ware health center.



The Ware personal care residents and staff collect toiletries to donate to Neighborhood Services in Oxford. The organization provides monetary assistance to pre-screened, income eligible individuals who need assistance meeting their basic needs and they provide a Food Bank that also includes diapers, personal care items, household cleaning supplies and paper products. The health center and personal care residents participate in making breast cancer awareness crafts to sell annually and donate the proceeds to the Susan G. Komen Foundation, which works to end breast cancer in the U.S. and throughout the world through ground-breaking research, community health outreach, advocacy and programs in more than 30 countries. Ware independent living residents are engaged in a large variety of volunteer projects in the surrounding community throughout the year.

The employees at Ware are also dedicated to community outreach including volunteering with the local cub scouts, holiday food drives, river sweep, VFW events, adopt a family for Christmas, local senior center events, church events, PTA, coaching local youth sports, photographing local school sports, and corollary sports and high school band events. Dining Services at Ware also assist the local community by providing an average of 65-75 meals per week for the Meals on Wheels program.

The Westminster Village talent show is an annual event showcasing a variety of talents of our residents and staff such as singing; dancing; guitar; piano and kazoo playing; juggling and poetry reading. The event was well attended by residents, staff and neighbors.

A wide range of groups and organizations are supported by Village residents and staff: Alzheimer's Support group meeting; American Red Cross annual blood drive; clinical site for Cedar Crest College and Lehigh Community College nursing students; Lehigh Valley Charter School; Lehigh County high school students fulfilling volunteer service hours; a pen pal program for elementary students writing letters to Village seniors; Second Harvest Food Bank donations; and Via of the Lehigh Valley clothing drive donation.



Westminster Village at Dover

Westminster Village is a continuing care retirement community located in the heart of Dover with 27 green and flowering acres. Dover, Delaware’s state capital, is close to major metropolitan areas yet situated comfortably in rural Kent County. Just 40 minutes from the Delaware beaches and neighbor to four area colleges and various art



and cultural events including the Schwartz Center for the Arts.

Westminster Village is the only CCRC in Delaware to participate in Masterpiece Living, a nationally recognized initiative that facilitates successful aging in senior living communities in a researched-based, measureable, holistic, and comprehensive fashion.

Westminster Village provides community benefits through various kinds of volunteerism.

The Westminster Village Thrift Shop is open to the entire Dover area, offering the purchase of needed items at a very low cost. Volunteers staff the Thrift Shop and the Village Nook Gift Shop, with proceeds dedicated to support benevolent care. Many outside groups utilize the facilities at Westminster Village, including New Castle Presbytery, Toastmasters and Alzheimer’s Associations.

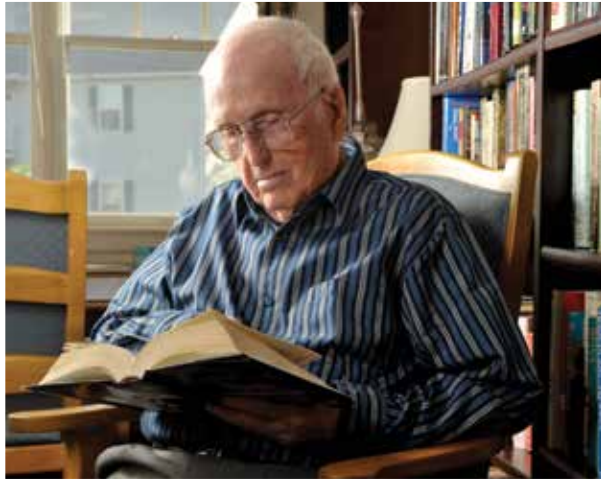

funding from resident projects, employee giving, the auxiliary and the Presbyterian Homes in the Presbytery of Huntingdon Foundation. Residents are the caretakers of the flowers and the herb garden with the first herb harvest being used in the dining services meal preparation.

Windy Hill Village, a Masterpiece Living community, is home to the Windy Hill Ringers.



Residents from all levels of care play hand chimes for in-house events and have also played at local churches. Recently, the group recorded a CD, "Ringing through the Seasons," for their families and to be available by special order (profits to go to benevolent

Affordable Housing Overview



PSL's affordable senior housing apartments offer quality living in a comfortable and safe environment. The affordable housing residents and staff are engaged in supporting their neighborhoods, hospitals, churches, local town and county agencies as a way of giving back to the community. The following are select examples of staff participation in community activities: serving on the York Town Suicide Prevention Coalition; Columbia County Jail ministry; helping to lead church services; and bible study and teaching adult Sunday school. Resident volunteer engagement also includes Meals on Wheels food bank and delivery service, church choirs, preschool and youth groups, and clerical support at local hospitals. Residents are also involved with reading programs for elementary school children, Cancer Society Daffodil Days and community gardens.

Presbyterian Senior Living Administrative Office

Presbyterian Senior Living (PSL) Administrative Office is located in Dillsburg, Pennsylvania. It is the nexus for communications and administrative oversight of all PSL communities located in Delaware, Maryland, Pennsylvania,



and southeastern Ohio. PSL is governed by a volunteer board of trustees. An important task for the board is to ensure that all programs and services for all communities are in harmony with the PSL mission statement. The PSL workforce is encouraged to be responsible citizens and work toward creating a better community and world.

Staff volunteer hours are dedicated to churches; schools; homeless shelters; Harrisburg Humane Society; and in Lancaster County the Coalition for Smart Growth and the Bicycle and Pedestrian Advisory Committee; the Presbyterian Board of Pensions; and Forgotten Voices International. Staff volunteers working in their hometowns are involved with parent teacher associations, public and private school sports teams, school board sponsored functions, scouting organizations and support for local civic and service organizations.

The PSL Learning Center, a state of the art suite, is used by other not-for-profit organizations for meetings and educational and training programs. Organizations using the learning center during the past year including the following: Monaghan Presbyterian Church, Vistage, PANAC board meetings, and the International Association of Administrative Professionals. The learning center is also used on a regular basis for staff training and a host of special events.

Two special groups that receive support from the administrative office are Forgotten Voices International (www.forgottenvoices.org), a group that provides support to children orphaned by AIDS in Zimbabwe and Zambia. FVI occupies office space in the farm house on the Carroll Village campus (provided free of charge) and support their activities in a variety

In addition to their work with seniors, they support a variety of programs that serve the needs of the severely disadvantaged in the Baltimore area. 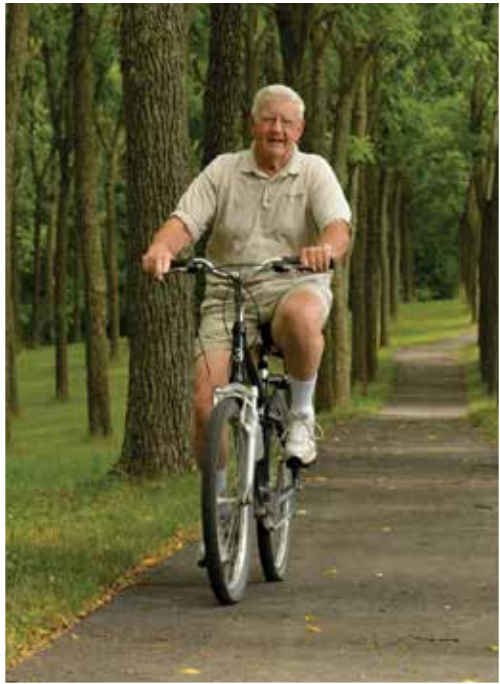
