<p>United States Foreign Relations in the 20th Century How the United States came to occupy a leading role in world affairs as a diplomatic, military, economic, and cultural power and what that role has meant to Americans and to other peoples, especially during the Cold War.</p>	<p>MAC 841: International Tax Focuses on the U.S. tax laws applicable to individuals and business operating abroad. Topics include jurisdiction, source of income, allocation and apportionment of deductions, foreign tax credit planning, anti-avoidance provisions, and transfer pricing.</p>	<p>Some MAC graduates go on to work abroad, often helping international companies with their U.S. tax obligations. Understanding how the rest of the world perceives America and our relationships with other countries will help you navigate professional relationships with people from other nations.</p>
<p>Introduction to Chinese History Chinese history from its beginnings to the present, organized around the central theme of how the identity of China was created.</p>	<p>MAC 863: Managing Workplace Diversity Designed to improve your awareness of the importance of effectively managing workplace diversity, not only as a social or moral goal, but also as a sound business practice. By increasing your appreciation of your own cultural values, you'll heighten your sensitivity to others and enhance your ability to manage people of diverse backgrounds.</p>	<p>You'll work on teams, including teams with people (and clients) from other countries and cultures. Understanding the history of other countries, along with professional management skills, will make you a much more effective accountant and manager, opening up opportunities for professional advancement.</p>
