is a newer feature for SentriSmart users. This new feature allows a listing agent to know when a showing has concluded. No action is needed by the showing agent; SentriSmart tracks distance from the property and access to other lockboxes to notify the listing agent that the showing has completed. Data Sharing with Jackson County

MichRIC has recently introduced a Data Sharing option with Jackson Association of REALTORS®. Members will find access to Jackson Association's MLS Data when logged into REALTORS® Property Resource (RPR). New Boat Launch Option in flexmls

All MichRIC members now have the option to select Boat Launch under Association Amenities in the MLS. This can be found in both Residential and Vacant Land properties. To add this option, visit the properties' **Change Residential Listing** page and select **Listing Information**. From here, you will select **Details** to scroll to the bottom and find **Association Amenities**. Simply select **Boat Launch** and don't forget to save your changes. Soon, this option will appear on the data input sheets that can be found in zipForms and dotloop.

MLS Fax Option No Longer Available

Flexmls has discontinued the fax in option, due to waning usage over the last year. On October 4th, 2017, the service to fax in documents to flexmls for uploading purposes, was disabled. Alternative tools are still available for all members, this includes scanning documents or using a mobile phone to create images or PDFs of the documents.
