## NAR Issue Brief: Tax Reform in 2017

Federal tax reform will be a hot topic in 2017. Given its focus on the campaign trail the last four election cycles and our most recent federal election results, expect formal proposals to be introduced and be debated in Congress in the coming months.

It will be important for Members to be aware of potential changes to federal tax code provisions that could impact ownership of real property. GKAR leadership will continue to engage with Michigan REALTORS® and NAR to advocate on these policy issues. NAR recently provided some information on the important tax policy provisions that have been discussed surrounding tax reform. Expect to hear more details from NAR soon.

## LARA 2017 Changes to Occupational Code - Article 25

For the past couple of years, Michigan REALTORS®' Public Policy Committee, with input from its Real Estate Licensing Task Force, has been working with the Department of Licensing and Regulatory Affairs (LARA) and the Michigan Legislature to overhaul Article 25 of the Occupational Code. This effort finally came to fruition at the end of 2016 with the passage of Public Act No. 502 of 2016. As redrafted, Article 25 is better-organized, uses more consistent terminology, and is intended to be easier to understand. Download White Paper
