## CONTINUING EDUCATION STATE REQUIREMENTS

### **Current Cycle:**

November 1st, 2015 - October 31st, 2018

### **Deadlines Within Current Cycle:**

November 1<sup>st</sup>, 2015 - October 31<sup>st</sup>, 2016 November 1<sup>st</sup>, 2016 - October 31<sup>st</sup>, 2017

November 1st, 2017 - October 31st, 2018

### Continuing Education Requirements if Licensed for the Entire Cycle:

- A total of 18 credit hours: at least 6 legal credit hours and 12 additional general or legal credit hours.
- You cannot receive credit for repeating a course within the current cycle.
- You must take 6 credit hours per year including the 2 legal credits, for a total of 18 credits at the end of the cycle.

### **Legal Credits:**

- You need a minimum of 2 legal credits every year for a total of 6 legal credits by October 31st, 2018.
- You may earn additional legal credits and apply them toward your overall balance of 18 total credits needed by October 31st, 2018, so long as you complete 2 legal credits every year.

### **Excess Credits:**

• Credits are only applicable to the current cycle you are in and will not be carried over to the 2019 - 2021 cycle.

### **Newly Licensed Agents:**

• An agent may be exempt from Continuing Education requirements depending on the date the license was issued.
