## Motor Club Services

### Benefits for you or your spouse when driving your personal vehicle

The five benefits listed below do not cover vehicles with more than two axles.

- 1. Emergency Travel Expense Reimbursement**  
Up to \$500 in expenses for commercial transportation, car rental, lodging, and meals. Coverage when your personal vehicle is disabled by collision with another vehicle or object more than 100 miles from your home.
- 2. Ambulance Service Reimbursement**  
Up to \$50 reimbursement if you or your spouse needs an ambulance due to an automobile accident in your personal vehicle.
- 3. Theft Reward**  
\$1,000 reward for information leading to the arrest and conviction of the thief stealing your personal vehicle.
- 4. Car Rental Discounts**  
Hertz. Alamo. Dollar.
- 5. Hotel/Motel Savings**  
You and your spouse can save at hotels and motels across the United States.

*Limitations: The above five Road America Motor Club services are the only benefits limited to your personal automobile of two axles, excluding trucks/commercial vehicles. See the Membership Handbook for complete details.*

# You don't want to be without the Commercial Drivers Legal Plan

## Tragic Accident Representation

If you or your spouse is charged with a criminal act due to a serious traffic accident, a Commercial Drivers Legal Plan Attorney will defend you in the court of original jurisdiction at no additional cost for the following charges:

- Manslaughter
- Involuntary manslaughter
- Vehicular homicide
- Negligent homicide
- Appeals are not covered

## Bail Bond Service

You and your spouse are entitled to bonds up to \$5,000 if you are charged with manslaughter, involuntary manslaughter, homicide, or negligent homicide as the result of driving a motor vehicle. If the bail bond is not accepted by law enforcement authorities or the court, call 1-800-232-8722. Bail bond is not available in Kentucky or Cook County, Illinois.

## Moving Violations

1. Defense of moving violations in the court of original jurisdiction at no added charge to you.
2. Defense by an attorney located through your Commercial Drivers Legal Plan Provider Attorney Firm at no added charge to you.
3. The attorney appointed for you is usually located in the area where you received the ticket.

## DOT and Non-Moving Violations

At no added charge, you and your spouse are entitled to defense of citations issued in your properly licensed and insured motor vehicle including:

- Logbook
- Overlength
- Overweight
- Overheight
- Load spill

- No placard
- No permit
- No medical card
- Hazardous material
- No motor carrier authority
- Expired inspection sticker

## Arrest Bond Protection

You and your spouse automatically qualify for an arrest bond certificate up to \$200 when charged with a covered traffic violation. If the arrest bond certificate is not accepted by law enforcement authorities or the court, call 1-800-232-8722. Arrest bonds are limited to \$100 in Montana and are not available in California.

## License Reinstatement

You and your spouse have 2.5 hours of legal help from a Commercial Drivers Legal Plan Attorney in each of the following situations if:

- You are denied a driver's license
- Your driver's license is cancelled, suspended, or revoked by the Department of Public Safety or Department of Motor Vehicles where a right to appeal is provided to you by statute.
- Assistance is needed to reinstate or maintain a driver's license because of job-related or medical reasons.

## Property Damage Collection

A Commercial Drivers Legal Plan Attorney will help you or your spouse collect property damage claims of \$2,000 or less for damage as a result of driving, riding in, or being struck by any motor vehicle or boat.

- Covers minor damage to your car or truck.
- You may receive up to 2.5 hours of attorney time per incident.

## Personal Injury Collection

A Commercial Drivers Legal Plan Attorney will help you or your spouse collect personal injury claims of \$2,000 or less for injuries resulting from driving, riding in, or being struck by any motor vehicle or boat. You may receive up to 2.5 hours of attorney time per claim.

## CSA Consultation

You can consult with the Provider Attorney about any points assessed against your record by the Federal Motor Carrier Safety Administration (FMCSA) pursuant to regulations of the FMCSA's Compliance, Safety, Accountability (CSA) program. Plus, an attorney will handle a challenge of any assessed points at the Preferred Member discount rate.

## All Other Transportation Related Legal Services

You and your spouse can also have an attorney's help with transportation-related legal services:

- Alcohol/drug cases
- Driving without a license
- No seat belt
- Parking tickets
- Bypassing scales
- Police scanner
- Driving on suspended license
- Improper or expired registration or tag

***You and your spouse can receive this and any other transportation related legal work not specifically covered by this plan at a 25% discount from the attorney's standard hourly rate. In order to obtain services at the 25% discount, you need to send a \$100 initial handling fee to the Provider Attorney first.***
