4. Circle the model and quantity of Philips HeartStart AED(s) purchased and purchase date on the authorized distributor sales receipt.
Note: your company name must be listed on the sales receipt and must match the company name listed on the rebate form.
5. Enclose **rebate form and original dated sales receipt** from a Philips authorized distributor for Philips HeartStart AED(s), carry case(s) and fast response kit(s).
6. Mail all items in a single envelope **within 30 days of purchase date and no later than November 15, 2016** to:
