CIO Briefing: What to Know about Creating Connected Workplaces

Much has been written about the need to transform to a digital workplace. The stakes are high. Former Cisco CEO John Chambers has predicted 40 percent of Fortune 500 companies will not exist in the next 10 years owing to a failure to adapt to the digital era. For most CIOs, digital workplace initiatives are on the radar if not the roadmap.

Digital workplace transformation is broad in scope and ambitious in its objectives. Though details vary, most digital workplace initiatives seek to increase employee engagement, support the changing nature of work, and align workplace technology with business objectives. This article will address a specific aspect of workplace transformation: creating connected workplaces. *A connected workplace is a collaborative environment that enables fast communication, information-sharing in real-time, and the ability to quickly work together to solve day-to-day business challenges.*



Top Use Cases Driving CIOs to Consider Connected Workplace Initiatives

Part of the changing nature of work is the number of people we must collaborate with on a daily basis just to get our work done. CEB found that <u>60 percent of us work with 10</u> <u>or more people daily</u>, and 63 percent of us regularly interact across different locations. With collaboration so integral to work, it's not surprising that the primary reason CIOs give for pursuing a connected workplace is to improve their employees' ability to quickly collaborate with remote colleagues.

We recently partnered with IDG Networks to better understand how CIOs are enabling the transformation to a connected and collaborative workplace. CEB calls the highly connected, collaborative worker an "enterprise contributor." They suggest that companies that develop enterprise contributors <u>have "twice the impact on financial outcomes.</u>" Despite the importance of creating and enabling highly collaborative workers, CEB found that only 17 percent of employees today are enterprise contributors.

The AVI-SPL/IDG study echoes that finding as only 16 percent of companies with 250-999 employees believed they had mastered the connected workplace. That percentage jumped to 41 in companies with more than 1,000 employees. For many of the rest, moving from the radar to the roadmap is a critical next step.

CIOs Share Top Challenges to Their Connected Workplace Initiative


What do you need to watch out for as you plan a connected and collaborative workplace? The CIOs in the AVI-SPL/IDG study shared a few challenges and concerns that surfaced in the planning phase. For 43 percent of CIOs, the top challenge is a lack of resources and budget. Other top challenges include:

- · Designing a space that fits with organizational culture/strategy
- Difficulty quantifying the benefits
- Choosing a technology as a standard
- · Technology integration and interoperability

CIOs Expect External Partners to Deliver Important Benefits

Most CIOs and IT teams will work with external vendors that specialize in designing, building, and managing communication and collaboration spaces. These relationships can accelerate connected workplace initiatives and provide many important benefits. The CIOs in our survey identified several benefits they expected from these vendors.

Fifty-seven percent of CIOs expect external vendors to reduce the burden on IT, followed by expecting them to provide access to the latest technologies (48 percent). When we look

at all respondents in the early planning phases of connected workplace initiatives, the top expected benefit is still to reduce the burden on IT (56 percent), closely followed by an expectation for optimized operations.
