



Dear Parent/Legal Guardian:

We were given your contact information by someone attempting to create a user account for a Blue Goji Corp. ("Blue Goji") product or service, such as Goji Play, for your child under the age of 13. In order for your child under the age of 13 to have a user account for a Blue Goji product or service, such as Goji Play, we are required under the United States' Children's Online Privacy Protection Act of 1998 ("COPPA") to obtain your permission to our online collection and use of your child's personal information.

With your permission, we may collect certain personal information from your child, such as his or her e-mail address, demographic and certain biometric information, precise location information (in connection with some of our apps), information about your child's interest in and use of the Goji Play games and our GojiVerse wellness platform, participation in our online community and other information as described in full in our Privacy Policy ([www.bluegoji.com/privacy](http://www.bluegoji.com/privacy)).

Because some of Blue Goji site or app features will enable your child to share his or her Goji Play activities and other personal information with other Goji Play members that he or she invites, we encourage you to monitor and supervise your child's activities during his or her use of our products and services. Even though we have designed a 3-tier user identity structure in an effort to promote private interactions, we cannot control what your child may share online.

At any time, you may withdraw your consent to our collection of personal information online from your child by giving us written notice at [support@bluegoji.com](mailto:support@bluegoji.com) or by fax at (512) 201-6720. Upon receipt of your request for withdrawal of permission for your child, we will disable your child's user account.

If you do not provide your consent or do not respond within 60 day, we will not collect personal information from your child online nor enable the creation of a user account for your child, and we will delete your contact information.
