Your privacy on the internet is of the utmost importance to us. Because we gather certain types of information about the users of this site, we feel you should fully understand the terms and conditions surrounding the capture and use of that information. This privacy policy discloses the privacy practices for this site (“this site”) – what information we gather, how we use it and how to correct or change it. This privacy policy only addresses our activities from our servers. ## General Privacy Information

Please keep in mind that whenever you voluntarily and publicly disclose personal information on any online service or website – for example through email – that information can be collected and used by others. ## Collection and Use of Information

This site collects information about you both from what you tell us and what we collect through the use of cookies (see Cookies below). Information collected about you is used in two different ways. Information is “aggregated” — meaning that the information from many users is grouped together in a way that does not disclose the personal information of any particular user. We may use this aggregated information to determine user traffic statistics for this site (including without limitation to determine browser usage, duration of stay, the referring URL, IP address geographical location, etc.) and to evaluate which products and services are successful and which ones are not, and in order to evaluate which new services we should make available on this site. We may use only the anonymous click stream data to help our advertisers deliver better-targeted advertisements. In addition, CHARGE may use

personal information collected through cookies and registration pages to target e-commerce promotions and telemarketing activities for products and services related to CAHRGE and/or its sponsors, advertisers and business partners. In addition, some of your personal information may be shared with third parties who assist CHARGE in producing its site or provide a service to this site's users.

It may be necessary – by law, legal process, litigation, and/or requests from public and governmental authorities within or outside your country of residence – for CHARGE to disclose your personal information. CHARGE may also disclose information about you if it is determined that for purposes of national security, law enforcement, or other issues of public importance, disclosure is necessary or appropriate. Additionally, in the event of a reorganization, merger, or sale CHARGE may transfer any and all personal information collected to the relevant third party.

### **Registration**

Anyone who participates in any interactive activities offered on this site may be asked to register for a free guest ID and password or to complete subscription registration for an ID and password. We use this contact information from this registration form to send the registrant information about CHARGE, CHARGE affiliates, CHARGE events and clients, and promotional material from some of our clients, sponsors, advertisers and business partners. Users may always opt-out of receiving any such information either by responding to the relevant communication as directed or by contacting this site (see Contacting the Site and Changing Your Personal Information below). Financial information that is collected may be used to bill the user for any products and services purchased from CHARGE. The registrant's contact information is also used to contact the user who has purchased good from this site when necessary for customer service reasons. Unique identifiers, such as ID and passwords, are collected to verify the user's identity and for use as account numbers in our record system.

### **Children Under 13**

This website is a general audience website. On this website, we do not currently knowingly collect any personal information from children under the age of thirteen. If, in the future, we collect personally identifiable information from children on the Website, we will do so in compliance with the Children's Online Privacy Protection Act of 1998 (15 U.S.C. 6501 et seq.) including, without limitation, obtaining necessary parental consent. If we learn that we have collected the personal information of a child under 13 we will take steps to delete the information as soon as possible.

### **Cookies**

A cookie is a small data file that certain websites write to your hard drive when you visit them. A cookie file can contain information such as a user ID that the site uses to track the pages you've visited. But the only personal information a cookie can contain is information you supply yourself. Generally, cookies work by assigning a unique number to the user that has no meaning outside the assigning site. A cookie can't read data off your hard disk or read cookie files created by other sites. This random number lets us keep track of "how many" times customers are doing specific things – like visiting our site each month – without really knowing who those customers are. We use cookies to deliver content specific to your interests and to save your member ID. Additionally, after you've entered your member ID and password during a session on our service, we save that information so you don't have to reenter it repeatedly during that session. Users should be aware that this site cannot control the use of cookies or the resulting information placed by advertisers or third parties hosting data for this site. If a user does not

All sensitive/credit information supplied by users is transmitted via Secure Socket Layer (SSL) technology and then encrypted in this site’s databases as stated above. CHARGE’s security policies are reviewed periodically and revised as required.

## **Contacting the Site and Changing Your Personal Information**

If you choose to modify your personal information or you have forgotten your password, you may do so by contacting CHARGE. You will be required to submit a valid user ID and password for authentication before you will be able to modify your file. Because password and credit card information has been encrypted, it is completely invisible to any employee who accesses it, including our customer service team.
