The Massachusetts RRP Lead Law, effective on 7/9/2010 is more stringent than the base EPA version. The **Mass RRP Law** introduces the **OSHA Lead Standard** as part of the regulation. This means companies must comply with Respiratory and Worker Protection Programs, medical monitoring, PPE and other related **OSHA** items. **To obtain a Mass RRP Lead License these items must be included with your application to qualify to work on pre 1978 properties.**
