## The EPA Renovate, Repair and Painting Rule went into effect on 4/22/2010.

Named 40 CFR Part 745, this law requires that renovations performed for compensation on pre-1978 homes, must be done by EPA Certified Firms using Certified Renovators. This includes contractors, sub-trades as well as landlords and property managers.

## The fines for non compliance are up to \$37,500 per violation per day.

Firms seeking certification must apply to the EPA and pay a fee. Contractors who work on pre-1978 homes, seeking to become a Certified Renovator, must successfully complete the EPA approved renovator course.

- Remodelers/Carpenters/Handyman
- Window/Siding/Gutter/Painting/HVAC & Roofing Contractors
- Electricians, Plumbers, Plasterers
- Flooring, Tile & Insulation Companies
- Housing Authority and Property Maintenance Workers, Landlords, Municipal Maintenance Staff.
- Any firm or entity who breaks paint on pre 1978 homes for compensation.
