



MEDICARE SUPPLEMENT NEW OHIO DISCLOSURE

September 12, 2012

NEW DISCLOSURE FORM:

Due to a regulatory change that was effective 9/6/12, on Assured Life Association Medicare supplement and SELECT applications in Ohio agents must also submit the new disclosure form attached (**T01_689_OH**) with each application.

One copy should be left with the applicant and the producer **must submit** the signed copy with the application. We will require the new disclosure to be submitted beginning with apps **signed and dated Saturday, September 29, 2012 and later.**

Applications signed and dated after **September 29, 2012** will be held in pending status until a signed disclosure form is received.

Upon application approval, a rider will be applied/sent to all Assured Life certificates for Ohio **issued 9/6/12 and later.**

The disclosure reads as follows:

ASSURED LIFE ASSOCIATION IS LICENSED TO DO BUSINESS IN THE STATE OF OHIO. AS A TAX-EXEMPT MEMBERSHIP ORGANIZATION, FRATERNAL BENEFIT SOCIETIES ARE NOT INCLUDED IN THE OHIO GUARANTY ASSOCIATION. THIS MEANS THAT FRATERNAL BENEFIT SOCIETIES CANNOT BE ASSESSED FOR THE INSOLVENCY OF OTHER LIFE INSURERS OR OTHER FRATERNAL BENEFIT SOCIETIES. BY LAW, A FRATERNAL BENEFIT SOCIETY IS RESPONSIBLE FOR ITS OWN SOLVENCY. IF THERE IS AN IMPAIRMENT OF RESERVES, A CERTIFICATE HOLDER MAY BE ASSESSED A PROPORTIONATE SHARE OF THE IMPAIRMENT. THIS PROCESS IS DESCRIBED IN THE CERTIFICATE ISSUED BY THE SOCIETY.

MATERIALS:

The new disclosure form T01_689_OH has been added to the application book, which is available to order through normal channels. Orders placed effective today will contain the new form.
