

Driving Agreement For

New Driver Contract

As you drive on your own and ride as a passenger in other vehicles driven by your friends, I/we believe it is very important to agree, in writing, as to what is expected and for you to understand the consequences of your actions or non-action. You are loved a great deal and I/we feel that the rules listed below are very important to your health and safety. Therefore, you are being asked to carefully read the following items and sign this agreement so there is no misunderstanding of expectations in the future.

1) Alcohol and Drugs*

A) You are not allowed to drink any alcohol, use any kind of drugs at any time prior to or during the time you are driving ANY vehicle or to possess any alcohol or drugs in a vehicle. Using alcohol or drugs is potentially a life and death decision, and any violation of this rule (no matter how small) will result in the loss of your license for _____ month(s).

B) You are not allowed to be a passenger at any time in any vehicle where the driver or any other passenger has been drinking alcohol, using drugs or has any alcohol or drugs. This is potentially a life and death decision, and any violation of this rule (no matter how small) will result in _____ month(s) prohibition of riding in another vehicle with anyone (other than a family member) and for anyone to ride with you while you are driving.

2) Reckless Driving*

If you are seen by anyone driving recklessly, or if you ride with anyone driving in a reckless manner, you will lose your license for _____ month(s). This includes driving at excessive speed, disobeying stop signs and lights.

3) Cell Phone Usage and Texting While Driving

Texting while driving is against the law. Cell phone usage while driving in Wisconsin is against the law for beginner (novice) drivers. If you are seen by anyone driving while talking on your cell phone, or texting while you are driving, you understand that this is against the law and that you will lose your license for _____ month(s). If you need to use the cell phone, you must pull over and stop the car before using.

4) Curfew

You are expected to know and follow the curfew laws. You are also expected to be home when you say you are going to be home or to call with a good reason why you will be late. If you violate this rule you will lose your license for _____ week(s).

5) Destination*

If you are found to have driven to or ridden to someplace where you are not supposed to be, you will lose your license for _____ month(s).

6) Tickets and Accidents

You are responsible for paying for _____% of your own vehicle insurance and for repair of any damage you may cause or are involved in an accident that you caused. If you receive a ticket or are involved in an accident, your insurance rates may substantially increase and you will be expected to pay for any increased amounts. Without insurance, you cannot drive. If you receive a ticket, you are responsible for 100% of that ticket amount.

7) Friends

Friends are not allowed to drive your vehicle unless it is an emergency. Violation of this rule will result in loss of your license for _____ month(s).

8) Grades

You are expected to maintain your normal good grades. If it becomes obvious that the use of a car is interfering with your schoolwork, then you will lose your license until the grades are improved.

9) Seat Belts

Wearing seat belts can be a life and death decision and in most states it is the law. Therefore, you must always wear your seat belt whether you are driving or riding as a passenger, and if you do not you will lose your license for _____ week(s).

10) General Use and Rules

There will be no driving around for the "fun of it". You must call to tell us where you are at all times, and confirm that you got where you said you were going.

* If at any time, for any reason, you find yourself in a situation where you are not comfortable or that may violate one of these rules then please contact me/us immediately – no one will ever be angry or upset if you ask for help.

I have read and understand these rules and I agree to not violate them. I also understand these rules (and penalties) are NOT negotiable and that there are NO SECOND CHANCES.
