TAKE NOTICE THAT:

1. On November 25, 2011, 1154944 Ontario Inc. (formerly AmbuTrans Inc.) (the "Company") filed a Notice of Intention to Make a Proposal pursuant to Subsection 50.4(1) of the *Bankruptcy and Insolvency Act* and A. Farber & Partners Inc. (the "Proposal Trustee") was appointed the Proposal Trustee.
2. On December 16, 2011, an Order was granted by the Court allowing the Company an extension of time for filing a Proposal to February 8, 2012.
3. The Company failed to file a Proposal with the Proposal Trustee on or before February 8, 2012, resulting in the Company being deemed to have made an assignment in bankruptcy on February 9, 2012. The Proposal Trustee was appointed as Trustee (the "Trustee") of the Estate of the Bankrupt by the Official Receiver, subject to affirmation by the creditors of the Trustee's appointment or substitution of another Trustee by the creditors.
4. The First Meeting of Creditors of the Bankrupt will be held on Thursday, March 1, 2012 at 2:00 pm at the offices of Farber Financial Group, 150 York Street, Suite 1600, Toronto, Ontario.
5. To be entitled to vote at the meeting, a creditor must lodge with the Trustee, before the meeting, a Proof of Claim and, where necessary, a proxy.
6. Enclosed with this Notice is a form of Proof of Claim, a form of proxy, and a list of creditors with claims amounting to twenty-five (\$25.00) dollars or more, showing the amounts of their claims.
7. Creditors must prove their claims against the Estate of the Bankrupt in order to share in any distribution of the proceeds realized from the Estate.







If the bankrupt is a corporation, you would be considered to be related to it if you were a shareholder or if your company was controlled by the same shareholders as the bankrupt corporation.

Item 6 – All Claimants must attach a detailed list of all payments or credits received or granted as follows:

- *within the three (3) months preceding* the bankruptcy or the proposal, in case where the claimant and the debtor are not related.
- *within the twelve (12) months preceding* the bankruptcy or proposal, in the case where the claimant and the debtor are related.

PROXY

All signatures must be witnessed.

A creditor may vote either in person or by proxy.

A debtor may not be appointed a proxy to vote at any meeting of his creditors.

The trustee may be appointed as a proxy for any creditor.

In order for a duly authorized person to have a right to vote he must himself be a creditor or be holder of a property executed proxy.

The name of the creditor must appear in the proxy.
