## COMPTEL *PLUS* Half-Day Workshop to Share Strategies for Striking the Right Balance with VoIP

The workshop will focus on how, as regulatory requirements for VoIP providers evolve, so must a company's business strategy. Speakers from a cross section of companies will explain their business strategies, and what they've done to establish or maintain regulatory compliance, improve profits and continue to grow market share. The workshop will be presented in three parts:

- VoIP Regulatory Strategies: One Size Does Not Fit All Company experts will explore relative merits of alternative regulatory strategies for competing in the telephony/VoIP markets.

- Optimizing Your Form 499 Strategy: Safe Harbor vs. Traffic Study and Managing Exemptions – Panelists will discuss ways that companies can maintain their competitive

edge by exploring alternatives to the VoIP "safe harbor" and best methods for managing exemptions to help reduce federal USF and other fees.
