## **Challenges in Finance Management**

As part of the ever growing efforts by Federal and local governments to restructure, align, and better manage budgets and resources, the need for the right solution to analyze, plan, and forecast is as critical as ever. For instance, the proposed 2013 \$3.8 trillion U.S. Federal budget contains an array of budget line-items, detailed resource allocations, and guidelines for nearly 500 official agencies and departments, exemplifying the complexities and challenges of budgeting and resource management.

Budget directives also require agencies to apply more rigorous methods that focus on the outputs and outcomes of activities using goal-oriented approaches such as performance-based or outcome budgeting. These methods, however, are time-consuming to implement and manage and can be complicated to sustain.

### **Current Tools May Not Be Enough**

The existing agency IT infrastructure that supports budget execution, formulation, and resource data primarily relies on data outputs from core financial, compensational, and other resource management systems. This data is then often manually re-entered into MS Excel, MS Access, VBA or other custom rigid solutions to perform analysis, budgeting and reporting activities. These systems are often inadequately integrated with the main systems of record; are prone to error and difficult to maintain and adjust; offer little or no user-driven or customizable analysis; and most importantly, lack the flexibility to adapt to new or changing requirements.

This assessment brings us to an obvious conclusion: In order to overcome increasingly complex budget management challenges, government agencies need to replace their current financial management solution with a specialized decision support system that is easy to implement, learn, maintain, and automate.
