# NDIA & SBTC Subcommittee on DCAA/DCMA Issues

The Small Business Technology Council ("SBTC" – www.sbtc.org) and the National Defense Industry Association ("NDIA" – www.ndia.org) Small Business Division formed a joint DCAA/DCMA Committee in the fall of 2013. This Committee is being chaired by one of Reli-Ascent's senior members, Russ Farmer.

This Joint Committee has been meeting quarterly with DCAA Headquarters personnel to identify, discuss and resolve broad based DCAA problems encountered by small businesses. The establishment of this important channel of communication has resulted in: a) DCAA participation in Small Business Conferences for both NDIA and Small **Business Innovation Research** (SBIR) National Conferences, b) Resolution of major issues with consultant costs in dated Incurred Cost Proposals, and c) current focus on establishing consistent cost treatment for allowable patent costs. Additional broad based issues are currently on the agenda. The goal of this Joint Committee is to reach resolution of each issue in a way that is in the best overall interest of the Department of Defense, the American taxpayer and the nation's defense industrial base. #### SBA's Office of Ombudsman, Regional Regulatory Fairness Board

Mike Anderson has been appointed to the U.S. Small Business Administration's Region VIII Regulatory Fairness Board by SBA Administrator Maria Contreras-Sweet. Regional Regulatory Fairness Boards in all 10 of SBA's regions represent the voice of small business on regulatory fairness issues. Each region's board is comprised of five small business owners /officers and serves as a resource and point of contact for small business owners who feel they have experienced excessive federal regulatory enforcement and compliance actions. SBA Region VIII includes Colorado, Utah, North Dakota, South Dakota, Wyoming, and Montana.

Regional Regulatory Fairness
Board members advise the National Ombudsman and Assistant Administrator for Regulatory Enforcement Fairness, Brian Castro.
The National Ombudsman and board members host regulatory fairness hearings within the region, nationally and outreach events nationwide where small business owners report concerns about burdensome federal regulations.

Each Regulatory Fairness (RegFair) Board shall meet at least annually to advise the Ombudsman on matters of concern to small businesses relating to the enforcement activities of agencies; report to the Ombudsman on substantiated instances of excessive enforcement actions of agencies against small business concerns including any findings or recommendations

of the Board as to agency enforcement policy or practice; and prior to publication, provide comment on the annual report of the Ombudsman to Congress.
