## Service

- If you need any of our products or services after business hours, call our emergency number to reach one of our store associates.
- Our associate will meet you at the store within an hour of your call (or as agreed during your call) and provide you with the same great service as always. Please show your *Hose & Fittings, Etc. Emergency Service Card* \* to the associate if s/he does not know you.
- The charge for the service of \$150 (\$175 on holidays) will be added to your invoice in addition to the cost of the parts and service.
- For our employees' safety, we do not keep any cash in the store after hours and we cannot accept cash payment after hours. Please charge your purchases to your open account or use a credit card, money order, or a company check to settle your invoice.

## How to get started

1. Please forward this information to a person in your company who can authorize others to use our service and ask them to let us know who in your company is authorized by filling out the information on the back page.
2. Once we receive a completed copy of the form, we will forward the Emergency Service Cards for all authorized contacts to the contact in charge. The cards list the phone number to call after business hours.
