Sliced Almond	15.00%	75
1 Minute Oats	17.00%	85
Rolled Oats	22.00%	110
Rice Crisps	9.00%	45
<b>Total</b>	<b>100.00%</b>	<b>500g</b>



### Procedure:

1. Add the binding syrup to the dry ingredients. Mix Well.
2. Press the mixture until the desired height is reached.
3. Cool to room temperature.
4. Cut into bars.
