As a full-service platform, MRCS enables HDVI to support your mission-critical retrieval processes with real-time visibility into every step.

We provide trained personnel for chart retrieval, as well as coding, quality assurance and review, overread (secondary and tertiary validation), and clinical quality review analytics.

Chase lists are provided by you in our standard load format. Loaded chases are assigned to our Provider Services team for outreach and retrieval management.

The Quality Assurance stage of our workflow is where we perform comprehensive review of incoming chart images to ensure completeness and accuracy, prior to coding/abstracting.

Our Provider Services team schedules and manages chart retrieval logistics for on-site visit, fax, mail, or remote access link. Remote link is through our proprietary technology, Secure Virtual Print (SVP), which allows providers to capture images (PDFs) from their EMR system and transmit them directly into MRCS via a secure connection.

We offer local, on-site retrieval teams on a national basis, who ensure the receipt of complete medical records and upload documents into MRCS.



The Chart Status Analytic and the Certified Not Retrievable (CNR) Dashboards allow you to see chart completion status in real-time, as well as how many completions represent actual received and reviewed charts, vs. chases closed due to irretrievable records.

Abstraction accuracy is measured in real time on the Overread Dashboard, which is accessible by you at all times.

Let HDVI take care of chart retrieval - you do the rest!


