### Retrospective Risk Projects

Real-time analytics track progress of your project and net impact on key metrics, such as submittable HCCs and operating metrics such as Coder IRR (a measure of coding quality), provider chart collection rates, and more.



### Year-Round Concurrent Review Projects

Concurrent Review allows you to perform chart reviews at time of receipt of a claim and to correct claims data before it is submitted to EDPS (Medicare) or EDGE (Commercial ACA), while not being pressed for sweep deadlines. It also allows you to solve gaps you've identified in your analysis. Why manage Risk retrospectively for 12-18 months periods when it is more effective to manage real-time, year-round?

Concurrent Review reduces provider abrasion and increases coding accuracy, with the platform providing a deep understanding of coder performance.

### Verify/Delete+Add

The V/D+A module assists in the review of charts against medical claims supplied for submission to EDPS or EDGE.

Submitted diagnoses are reviewed for allowing the verification or deleting those not supported in chart documentation. Although removing a diagnosis can decrease revenue in the short term, it is negligible compared to the long term financial impact if a systematic occurrence is found during a RADV audit.
