Public Reference Guide for Businesses and Other Organizations

Brazoria County Stay Safe at Home Order March 26, 6:00 P.M. through April 3, 11:59 P.M.

Brazoria County's temporary Stay Safe at Home Order, effective March 26, 2020, allows many businesses and organizations to continue operating and/or providing services to the public, including, but not limited to, those listed below.

- Health operations such as hospitals, healthcare clinics, dental clinics, pharmacies, mental health providers, and any ancillary healthcare service.
- Home-based and residential-based care for seniors, adults, or children.
- Veterinary care and health and welfare services provided to animals.
- Food service providers such as grocery stores, warehouse stores, "big-box" stores, and convenience stores.
- Food cultivation operations such as farming, fishing, and livestock.
- Restaurants and other businesses that prepare food for delivery, take-out, and/or drive-through.
- Businesses that ship or deliver groceries, food, goods, or services directly to residences.
- Micro-breweries, micro-distilleries, and wineries that provide delivery, carry-out, and/or drive-through.
- Schools or other entities that provide free goods or services for pick-up, take-away, and/or delivery.
- Laundromats, dry cleaners, and other laundry service providers.
- Gas stations.
- Auto supply stores; auto dealerships; and auto, R.V., and bicycle repair businesses.
- Hardware stores and related businesses.
- Businesses that supply products needed for people to work from home.
- Businesses and organizations that provide food, shelter, social services, and other necessities to economically disadvantaged or needy individuals.
- Trash and recycling collection, processing, and disposal.
- Mail and shipping services.
- Building cleaning, maintenance, and security.

- Lawn care services.
- Warehouse operations for distribution and fulfillment services.
- Funeral homes, crematoriums, and cemeteries.
- Professional services necessary to assist in compliance with legally mandated activities, such as legal services, accounting services, title companies, surveyors, and appraisers.
- Real estate services related to current real estate transactions.
- Newspapers, television, radio, and other media services.
- Commercial and residential construction, including residential repairs.
- Financial institutions.
- Industrial plants.
- Critical labor union functions.
- Businesses operating or maintaining in a "critical infrastructure sector," including the following (for more information, see CISA "Guidance on the Essential Infrastructure Workforce"):
 - \Rightarrow Healthcare and public health;
 - \Rightarrow Law enforcement, public safety, and first responders;
 - \Rightarrow Food and agriculture;
 - ⇒ Energy industry, including electricity, petroleum, and natural and propane gas;
 - \Rightarrow Water and wastewater;
 - \Rightarrow Transportation and logistics;
 - \Rightarrow Public works;
 - \Rightarrow Communications and information technology; and
 - \Rightarrow Certain community-based government operations.
- Businesses that supply support and necessary supplies to essential businesses under the Stay Safe at Home Order.
- Businesses that provide services necessary to the safety, sanitation, and essential operation of residences and essential businesses under the Stay Safe at Home Order.
- Storage services for essential businesses under the Stay Safe at Home Order.
- Childcare facilities providing services to employees working for essential businesses under the Stay Safe at Home Order.

To the extent possible, businesses and organizations operating during the temporary Stay Safe at Home Order should take measures for individuals to maintain social distancing of at least six feet from any other person. Please also remember to isolate at home if you or someone in your household has tested positive for coronavirus.
