





FEES FOR INTER-COUNTRY ADOPTION SERVICES AGREEMENT

For Prospective Adoptive Parents <u>NOT</u> Using Family Connections, Inc. as a Primary Provider

Family Connections Inc.'s Fee for Inter-Country Adoption Services Agreement is applicable to applications received on or before December 31, 2018. This agreement details the fees and estimated expenses for home study investigation services and post-placement/adoption services. Family Connections, Inc. encourages you to retain an attorney who specializes in adoption law to help you make judgment before signing this agreement.

Upon signature of this Fees for Inter-Country Adoption Services Agreement and your Adoption Services Contract, these fees are valid until the placement of a child in your home. If you wish to adopt again, you will be required to enter into a new Adoption Services Contract and agree and consent to the Agency's current Fees for Inter-Country Adoption Services Agreement.

Family Connections, Inc. is a fees for services agency and thus you will only be responsible for the fees associated with the services you purchase from the Agency. Please carefully review this Agreement and initial each item you may be responsible for and sign the Agreement.

Post-placement and post-adoption supervision services are pre-paid by the prospective adoptive parents at the time of their review of the home study draft report and signature of the "Agreement of Cooperation with Post-Placement/Adoption Requirements for International Adoption". These fees are fully refundable to the prospective adoptive parents if (1) the prospective adoptive parents do not receive placement of a child for adoption, (2) fewer visits are required by the country of origin (fees for visits not required will be refunded), or (3) the family moves out of state and has the post-placement or post-adoption supervision visits/reports completed by another authorized/licensed adoption agency (proof of completion of each visit/report must be provided to Family Connections to request a refund of fees).

- (2) Not refundable (unless otherwise specified in this Agreement, the Adoption Services Contract, and/or the Agreement of Cooperation with Post-Placement/Adoption Requirements for Domestic/International Adoption).
- (3) To be paid to Family Connections, Inc. in the form of personal check, money order, or cashier's check.
- (4) To be considered estimates that may change depending upon the circumstances of the adoption and costs of other adoption entities (e.g. other adoption agencies, attorneys, etc.). Family Connections, Inc. makes all efforts to the best of the Agency's knowledge and experience to identify and limit expenses that are estimated in this Agreement. However, there are fees that are not predictable and are not within the Agency's power to control due to the inherent circumstances and risks of the adoption process.
- (5) To be paid in full for Family Connections, Inc. to grant consent to adoption.
