

Member Referral Challenge Sweepstake
OFFICIAL RULES

BY ENTERING THE SWEEPSTAKE, YOU AGREE TO THESE OFFICIAL RULES, WHICH ARE A CONTRACT, SO READ THEM CAREFULLY BEFORE ENTERING. WITHOUT LIMITATION, THIS CONTRACT INCLUDES INDEMNITIES TO THE SWEEPSTAKES ENTITIES FROM YOU AND A LIMITATION OF YOUR RIGHTS AND REMEDIES.

1. **SWEEPSTAKES PERIOD:** IFT Membership Referral Challenge Sweepstakes (the “Sweepstakes”) begins on October 14, 2019 at 12: 00 AM Central Time (“CT”) and ends on February 17, 2020 at 11:59 PM CT (the “Sweepstakes Period”). Sponsor’s computer is the official clock for the Sweepstakes. This promotional sweepstakes is sponsored by IFT.

2. **ELIGIBILITY:** This promotion is a referral program through which current members of IFT who refer new members who joins as a Premier or Networking & Engagement Member will be entered to win a 12-month IFT membership and an IFT20 prize package. Winners may only receive one 12-month membership but may gift a second 12-month membership to another individual of their choosing if they win a monthly prize in addition to the IFT20 prize package. IFT members who refer new members who join as Student members are entered into the monthly drawing to win a 12-month IFT membership in addition to a separate IFT20 travel prize. Employees of IFT and its related organizations and their immediate family or household members are not eligible to enter or win. Entrants must be legal residents of the United States and be over the age of 18. IFT reserves the right to disqualify participants who violate these Official Rules or interfere with this Sweepstakes in any manner.

3. **HOW TO ENTER**

METHOD OF ENTRY: NO PURCHASE NECESSARY TO ENTER OR WIN. Entrants will be entered each time a new member includes the referrer’s name on the new member’s membership application and with an accompanying payment of membership dues. Eligible individuals may enter the sweepstakes by simply filling out a postcard with his/her name, IFT Member ID number, and address and indicate the sweepstakes they are entering and mailing it to the Institute of Food Technologist, c/o Susan Andronowitz, 525 W. Van Buren, St Ste 1000, Chicago, IL 60607. New membership applications or postcards must be received by IFT by 11:59PM CT on February 17, 2020.

LIMITS: Entries generated by script, macro, robotic or by any other automatic or mechanical means are void. All entries become the property of Sponsor and will not be acknowledged or returned.

ENTRANT DATA AND PRIVACY: Submission of the registration form and prize notification documents (“Entrant Data”) constitutes your consent for IFT to obtain use, and transfer your name, address and other details for Sweepstakes administration purposes. Any Entrant Data shall be used only in a manner consistent with the consent given by entrants at the time of entry, with these Official Rules, and with IFT’s Online Privacy Policy, which can be found at: <https://www.ift.org/about-ift/policies/privacy-policy>. It is the general policy of Sponsor not to share personally identifiable information with third parties.

4. PRIZES, PRIZE DRAWING, AND ODDS OF WINNING

PRIZE DRAWING: Prize Drawing will be conducted by Sponsor. There will be one (1) individual random IFT20 All Access Prize drawing winner from all eligible entries. The IFT20 All Access Prize winner will be chosen at random from current IFT members who refer new members who join IFT as a Premier or Networking & Engagement Member. There will be one (1) individual random IFT20 Travel Prize drawing winner from all eligible entries. The IFT20 Travel Prize winner will be chosen at random from current IFT members who refer new members who join IFT as a Student member.

Current IFT members who refer a new member who joins IFT as a Premier, Networking & Engagement, or a Student Member will be entered into a monthly drawing to win a 12-month IFT membership. All referral winners may only receive one 12-month membership for the duration of the campaign. If randomly selected to win a second 12-month membership as a part of the IFT20 all access prize, the second membership may be gifted to another individual of their choosing who resides within the United States.

Prize drawings for 12-month IFT membership will occur during the Sweepstakes Period on or by the 5th business day of the month in the months of November, December, January, and February for the month prior (October, November, December, January).

Prize drawings for the IFT20 All Access Prize package and IFT20 Travel Prize will be conducted on or about February 25, 2020. Odds of winning depend on the number of eligible entries received. Non-winning entries will not carry forward to or be included in subsequent sweepstakes or prize drawings of Sponsor.

PRIZE DETAILS: Total of six (6) prizes will be awarded throughout the referral challenge. One (1) 12-month IFT membership (value up to \$209, plus home section dues) will be awarded at random each month in addition to one (1) IFT20 All Access Package as well as one (1) IFT20 Travel Prize.

The winner of the IFT20 All Access Prize Package will receive one (1) IFT20 All Access Pass, reimbursement on airfare to Chicago (up to \$500), four (4) complimentary nights of hotel stay at a conference hotel (to be chosen by IFT), and roundtrip ground transportation to and from the hotel/airport. The winner of the IFT20 Travel Prize will receive reimbursement on travel and/or hotel accommodations to Chicago for IFT20 up to \$500. Travel and hotel reimbursement will be awarded after attendance of IFT20 with receipts submitted. All Prizes will be awarded, provided more than enough entries have been received. Sponsor will not replace any lost or stolen prize element. The IFT20 prizes will be awarded in the name of the Winners and are not transferable. The prize for the 12-month membership is only transferable if the winner has randomly been selected as the winner of a 12-month membership and the IFT20 all access prize, in such case the winner may gift one (1) 12-month membership to an individual of their choosing whom resides within the United States. All federal, state and local taxes and any other costs

associated with the acceptance or use of a prize are the sole responsibility of the winner. Decisions of the Sponsor and Administrator are final in all respects of the Sweepstakes. The total ARV for the 12-month membership ranges from \$25–\$244 depending on the member type and home section dues. The ARV for the IFT20 All-Access Prize ranges from \$1,855–\$2,634 (varies based upon hotel rates & dates). The ARV for the IFT20 Travel Prize is up to \$500 (varies based upon the travel costs of the individual, but shall not exceed \$500). All prizes awarded are subject to verification of eligibility and compliance with these Official Rules.

PRIZE AWARDING: Limit: One (1) 12-month Prize per person or household. Only the published number of Prizes stated in these Official Rules will be awarded. No transfers, (except in the case of an individual winning a 12-month membership prize in addition to the IFT20 all access prize) cash awards, or prize substitutions are permitted, except by Sponsor. Sponsor reserves the right to substitute a prize with one of comparable or greater value, at its sole discretion. An individual may only win one IFT20 Prize package. An individual may win one (1) 12-month prize and one (1) IFT20 prize package, either the IFT20 All Access Prize Package or the IFT20 Travel Prize. If randomly selected to win both IFT20 prize packages the individual will be awarded the prize of greater value and removed from the drawing for the IFT20 Travel prize. Prize winners will be required to provide a valid shipping address, as applicable, and may be required to sign an affidavit of eligibility, liability release and where legal, a publicity release (collectively, the “Affidavit”), and return same, properly executed, within seven (7) days of issuance of notification. Prize winner of the IFT20 All Access Prize package will be reimbursed up to a total of \$500 for all eligible airfare incurred with attending IFT20 after confirmation of attendance at IFT20. As part of the IFT20 All Access Prize package, lodging expenses will be paid for by IFT for the nights of Sunday, July 12, Monday, July 13, Tuesday, July 14, and Wednesday July 15 or Saturday, July 11, Sunday, July 12, Monday, July 13, Tuesday, July 14. Round trip transportation to and from the airport to the hotel will be paid for by IFT. Food and beverage expenses, transportation, and other onsite incidental expenses do not qualify for reimbursement. Prize winner of the IFT20 Travel Prize will be reimbursed up to a total of up \$500 for all eligible airfare and/or hotel accommodations incurred with attending IFT20 after confirmation of attendance at IFT20. Reimbursement will be awarded after attendance of IFT20 is confirmed and receipts are submitted to IFT. Winners must provide hotel, airfare and/or transportation receipts no later than Monday August 10, 2020. If a potential winner cannot be contacted after a reasonable number of attempts; is ineligible according to these Official Rules; fails to provide the required information and/or return the required documents within the specified time period; if a prize or prize notification is returned as undeliverable; a potential winner decide to decline his/her prize for any reason whatsoever, or if potential winner otherwise fails to fully comply with these Official Rules, he/she will forfeit his/her prize and the prize may be awarded to an alternate winner from among all remaining eligible entries received, in the Sponsor’s sole discretion. Upon disqualification, no compensation will be given. Once the required information and official paperwork are received within the specified time period, verified, and receive final approval by Sweepstakes Entities, then and only then will a potential Sweepstakes winner become an actual winner. Winners will be asked to share with IFT a story and photograph for use in future promotion of the program. Winners will be asked to complete a survey about IFT, the referral challenge and IFT20 will also be submitted to the winner with a request to be completed.

5. CONDITIONS OF ENTRY: Proof of transmission of an online registration form (such as a copy of the message in a “sent” or similar folder or a “thank you” screen or message) does not constitute proof of actual receipt by Sponsor of an entry for purposes of this Sweepstakes. Sweepstakes Entities are not responsible for incorrect or inaccurate transcription of entry information, or for any human or printing error in these rules or any promotional materials, technical malfunctions, lost/delayed data transmissions, omission, interruption, deletion, defect, line failures of any phone network, computer equipment, software, inability to access any online service or Web site, or any other error or malfunction, or any injury or damage to participant’s or any other person’s computer related to or resulting from participation in this Sweepstakes, or for late, lost, stolen, illegible or misdirected entries. Entry materials that have been tampered with or altered are void. If, in the Sponsor’s opinion there is any suspected or actual evidence of electronic or non-electronic tampering with any portion of this Sweepstakes, or if any difficulties compromise the administration, security, fairness, integrity, or proper conduct of the Sweepstakes, the Sponsor reserves the right to void any entries at issue and/or to suspend, modify or cancel, or terminate this Sweepstakes, in whole or in part, at any time without notice and award the prizes in a random drawing from among all non-suspected eligible entries received as of the termination date. In case of a dispute as to the owner of an online entry, online entry will be deemed to have been submitted by the authorized account holder of the email address from which the entry is made. The authorized account holder is deemed as the natural person assigned to an email address by an Internet access provider, service provider, or other organization responsible for assigning email addresses or the domain associated with the submitted email address. In the event of time of war, national emergency, accident, dangerous weather conditions, fire, riot, strike, lock-outs, industrial disputes, acts of terrorism or other matters beyond the Sponsor’s reasonable control, Sponsor has the right, in its sole discretion, to terminate the Sweepstakes. Caution: Any attempt by a participant or any other individual to deliberately damage any wireless or online service or website or undermine the legitimate operation of the Sweepstakes may be a violation of criminal and civil laws and should such an attempt be made, the Sponsor reserves the right to seek damages and/or other remedies from any such person to the fullest extent permitted by law.

7. DISPUTES: This Sweepstakes is conducted in English. Except where prohibited, all issues and questions concerning the construction, validity, interpretation, and enforceability of these Official Rules, or the rights and obligations of the participant and Sponsor in connection with this promotion, shall be governed by, and construed in accordance with, the laws of Illinois, without giving effect to any choice of law or conflict of law rules (whether of Illinois, or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than in Illinois.

KNOWINGLY AND EXPRESSLY WAIVES ALL RIGHTS TO SEEK, PUNITIVE, INCIDENTAL, CONSEQUENTIAL OR SPECIAL DAMAGES, LOST PROFITS AND/OR ANY OTHER DAMAGES, OTHER THAN ACTUAL OUT OF POCKET EXPENSES NOT TO EXCEED FIFTY DOLLARS (\$50.00), AND/OR ANY RIGHTS TO HAVE DAMAGES MULTIPLIED OR OTHERWISE INCREASED; AND (4) ENTRANTS' REMEDIES ARE LIMITED TO A CLAIM FOR MONEY DAMAGES (IF ANY) AND ENTRANT IRREVOCABLY WAIVES ANY RIGHT TO SEEK INJUNCTIVE OR EQUITABLE RELIEF. SOME JURISDICTIONS DO NOT ALLOW THE LIMITATIONS OR EXCLUSION OF LIABILITY, SO THE ABOVE MAY NOT APPLY TO YOU.

9. **MISCELLANEOUS:** The invalidity or unenforceability of any provision of these Official Rules or the Affidavit will not affect the validity or enforceability of any other provision. In the event that any provision of the Official Rules or the Affidavit is determined to be invalid or otherwise unenforceable or illegal, the other provisions will remain in effect and will be construed in accordance with their terms as if the invalid or illegal provision were not contained herein. Sponsor's failure to enforce any term of these Official Rules will not constitute a waiver of that provision. When terms such as "may" are used in these Official Rules, Sponsor has sole and absolute discretion. Entrants agree to waive any rights to claim ambiguity of these Official Rules. Headings are solely for convenience of reference and will not be deemed to affect in any manner the meaning or intent of the documents or any provision hereof. In the event there is a discrepancy or inconsistency between disclosures or other statements contained in any Sweepstakes-related materials, privacy policy or terms of use on the Website and/or the terms and conditions of the Official Rules, the Official Rules shall prevail, govern and control and the discrepancy will be resolved in Sponsor's sole and absolute discretion.
