OFFICIAL RULES

BY ENTERING THE SWEEPSTAKES, YOU AGREE TO THESE OFFICIAL RULES, WHICH ARE A CONTRACT, SO READ THEM CAREFULLY BEFORE ENTERING. WITHOUT LIMITATION, THIS CONTRACT INCLUDES INDEMNITIES TO THE SWEEPSTAKES ENTITIES FROM YOU AND A LIMITATION OF YOUR RIGHTS AND REMEDIES.

**1. SWEEPSTAKES PERIOD:** IFT Membership Campaign Sweepstakes (the "Sweepstakes") begins on 3/5/2018 at 12:00 AM Central Time ("CT") and ends on 4/8/2018 at 11:59 PM CT (the "Sweepstakes Period"). Sponsor's computer is the official clock for the Sweepstakes. This promotional sweepstakes is sponsored by IFT.

**2. ELIGIBILITY:** This promotion is for student members of IFT and for the purpose of recruiting new IFT members. Employees of IFT and its related organizations and their immediate family or household members are not eligible to enter or win. Entrants must be over the age of 18. IFT reserves the right to disqualify participants who violate these Official Rules or interfere with this Sweepstakes in any manner.

**3. HOW TO ENTER:**

METHOD OF ENTRY: NO PURCHASE NECESSARY TO ENTER OR WIN. Entrants qualify for the contest by being listed as the referring member when a member joins IFT during the sweepstakes period, or by filling out a postcard with his/her name, IFT Member ID number, and address and indicate the sweepstakes they are entering and mailing it to the Institute of Food Technologists, c/o Katie Masterson, 525 W. Van Buren, Chicago IL 60607. Postcard must be postmarked no later than April 7, 2018 to qualify.

LIMITS: There is no limit on number of entries per person for the Sweepstakes Period. Entries generated by script, macro, robotic or by any other automatic or mechanical means are void. All entries become the property of Sponsor and will not be acknowledged or returned.

ENTRANT DATA AND PRIVACY: Submission of the registration form and prize notification documents ("Entrant Data") constitutes your consent for IFT to obtain, use, and transfer your name, address and other details for Sweepstakes administration purposes. Any Entrant Data shall be used only in a manner consistent with the consent given by entrants at the time of entry, with these Official Rules, and with IFT's Online Privacy Policy, which can be found at: <http://www.ift.org/about-us/privacy-policy>. It is the general policy of Sponsor not to share personally identifiable information with third parties.

**4. PRIZES, PRIZE DRAWING, AND ODDS OF WINNING:**

PRIZE DRAWING: Prize Drawing will be conducted by Sponsor. There will be up to ten (10) individual random Prize Drawings from all eligible entries. Prize Drawings will be conducted on or about 4/16/18. Odds of winning depend on number of eligible entries received. Non-winning entries will not carry forward to or be included in subsequent sweepstakes or prize drawings of Sponsor.

PRIZE DETAILS: Total of up to ten (10) prizes. The winner(s) will receive one (1) full student registration to IFT18. All Prizes will be awarded, provided more than enough entries have been received. Sponsor will not replace any lost or stolen prize element. Prize will be awarded in the name of the Winners. All federal, state and local taxes and any other costs associated with acceptance or use of a prize are the sole responsibility of the Winner. Decisions of the Sponsor and Administrator are final in all respects of the Sweepstakes. The total ARV of all prizes available to be won is: \$750. All prizes awarded are subject to verification of eligibility and compliance with these Official Rules.

PRIZE AWARDING: Limit: One (1) Prize per person or household. Only the published number of Prizes stated in these Official Rules will be awarded. No transfers, cash awards, or prize substitutions are permitted, except by Sponsor. Sponsor reserves the right to substitute a prize with one of comparable or greater value, at its sole discretion. Prize winners will be required to provide a valid shipping address, as applicable, and may be required to sign an affidavit of eligibility, liability release and where legal, a publicity release (collectively, the "Affidavit"), and return same, properly executed, within seven (7) days of issuance of notification. Prize winners will be provided with a registration code to a complimentary student registration to IFT18, taking place in Chicago July 15-18, 2018. Travel, lodging, and meal expenses are not included with the prize. If a potential winner cannot be contacted after a reasonable number of attempts; is ineligible according to these Official Rules; fails to provide the required information and/or return the required documents within the specified time period; if a prize or prize notification is returned as undeliverable; a potential winner decide to decline his/her prize for any reason whatsoever, or if potential winner

otherwise fails to fully comply with these Official Rules, he/she will forfeit his/her prize and the prize may be awarded to an alternate winner from among all remaining eligible entries received, in the Sponsor's sole discretion. Upon disqualification, no compensation will be given. Once the required information and official paperwork are received within the specified time period, verified, and receive final approval by Sweepstakes Entities, then and only then will a potential Sweepstakes winner become an actual winner.

Sweepstakes Entities are not responsible for incorrect or inaccurate transcription of entry information, or for any human or printing error in these rules or any promotional materials, technical malfunctions, lost/delayed data transmission, omission, interruption, deletion, defect, line failures of any telephone network, computer equipment, software, inability to access any online service or Web site, or any other error or malfunction, or any injury or damage to participant's or any other person's computer related to or resulting from participation in this Sweepstakes, or for late, lost, stolen, illegible or misdirected entries. Entry materials that have been tampered with or altered are void. If, in the Sponsor's opinion, there is any suspected or actual evidence of electronic or non-electronic tampering with any portion of this Sweepstakes, or if any difficulties compromise the administration, security, fairness, integrity, or proper conduct of the Sweepstakes, the Sponsor reserves the right to void any entries at issue and/or to suspend, modify or cancel, or terminate this Sweepstakes, in whole or in part, at any time without notice and award the prizes in a random drawing from among all non-suspect eligible entries received as of the termination date. In case of a dispute as to the owner of an online entry, online entry will be deemed to have been submitted by the authorized account holder of the email address from which the entry is made. The authorized account holder is deemed as the natural person assigned to an email address by an Internet access provider, service provider, or other organization responsible for assigning email addresses or the domain associated with the submitted email address. Sponsor's failure to enforce any term of these Official Rules will not constitute a waiver of that provision. When terms such as "may" are used in these Official Rules, Sponsor has sole and absolute discretion. Entrants agree to waive any rights to claim ambiguity of these Official Rules. Headings are solely for convenience of reference and will not be deemed to affect in any manner the meaning or intent of the documents or any provision hereof. In the event there is a discrepancy or inconsistency between disclosures or other statements contained in any Sweepstakes-related materials, privacy policy or terms of use on the Website and/or the terms and conditions of the Official Rules, the Official Rules shall prevail, govern and control and the discrepancy will be resolved in Sponsor's sole and absolute discretion.
