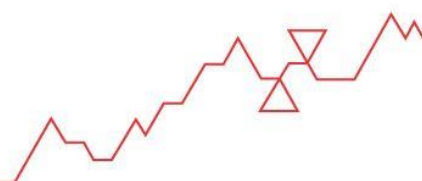

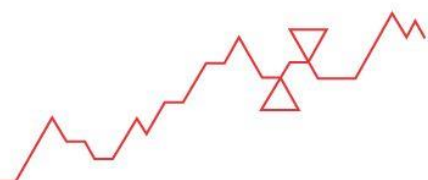

## 1. INTRODUCTION
